

#### Vance County Water District **Operations Report** April 2016







# Committee Reports and Recommendations

# Vance County Committee Reports and Recommendations May 2, 2016

#### **Human Resources Committee**

Salary and Classification Study. The Human Resources committee (Brown [C], Taylor & Wilder) met Monday, April 25<sup>th</sup> to continue a discussion from the planning retreat in January regarding the need for a salary and classification study. Staff reviewed issues the county is experiencing with high turnover particularly in the public safety departments and social services, as well as issues with lagging salaries and compressed pay scales. Staff informed the committee that funding has been included in the recommended budget for a study and also for merit pay increases tied to performance evaluations which will begin to address salary compression. The committee discussed the need to monitor the issues with salaries until a study is completed and requested that staff inform the committee of areas where significant salary differences are present. Additionally the committee discussed the importance of rewarding employees and requested that staff consider an incentivized rewards program that will celebrate employee accomplishments. For your information.

GIS Administrator position. The committee was informed of plans to relocate and fill the existing budgeted GIS administrator position. From a functional standpoint, the position will be located under the IT department which will better position it to serve multiple departments. Primarily the position will serve the planning department and the tax office through mapping parcels and also making the necessary changes in the tax office parcel records. Additionally the position will support E-911 through mapping of road centerlines and other public safety mapping layers and will be available to assist all departments and the public in their mapping needs. Staff intends to proceed with filling the currently budgeted position. For your information.

#### **Properties Committee**

Offers to Purchase REO Property. The committee (Brummitt [C], Wilder & Kelly [absent]) met Monday, April 25<sup>th</sup> to review an offer to purchase a county owned property on Angel Lane (tax parcel 0612 03001). The offer totals \$4,500 and covers all taxes, interest and attorney's fees for the property. The committee felt the offer was adequate and discussed their desire for having the structure removed or brought up to the county's minimum standards within 6 months of purchase. Recommendation: Approve resolution authorizing the upset bid process for the sale of Angel Lane (Tax Parcel 0612 03001) with the condition that the home be demolished or plans be submitted for restoration within 6 months and completed within 18 months.



A. Capital Improvement Plan. A Capital Improvement Plan (CIP) is a five year fiscal planning tool used to identify capital projects and coordinate the financing and timing of those projects. This process has allowed department heads the opportunity to identify capital needs over the next several years and bring those to the attention of our County leaders. The CIP is a working document and will be reviewed and updated as necessary to reflect changing needs and available funds throughout the County. A CIP was drafted by County staff and presented to the Board of Commissioners at two planning work sessions to solicit input and recommendations. A finalized document based on those work sessions is being submitted for your consideration at this time. *Recommendation: Adopt the Capital Improvement Plan for fiscal years 2017-2021 as presented.*

# County Manager's Report

## Vance County County Manager's Report to the Board May 2, 2016

- **A. Presentation of FY 2016-17 Proposed Budget.** We will transmit the proposed FY 2016-17 Vance County Budget to you on Monday evening. We will provide just a brief synopsis of the budget and ask that you consider setting work sessions on May 9 and 10 to review the proposed budget in detail. The public hearing on the budget will be set for the evening of June 6, which is the date of your regular meeting. Receive the FY 2016-17 Proposed Budget and Schedule Budget Hearing for the June 6 regular meeting.
- **B. One NC Fund Grant Ardagh Glass, Inc.** The board approved the local incentive agreement for Ardagh Glass, Inc. at last month's meeting. The local agreement ensures the local plant will create a capital investment of \$42 million and retain 259 local jobs. At that time we mentioned we would be coming back the following month to approve the OneNC grant agreement. We have been informed from NC Commerce that Wilson County will act as the administrator on the OneNC grant since both the Wilson County and Vance County facilities are receiving upgrades. Therefore Vance County will not be required to take action or approve the OneNC agreement. *For Your Information*.
- **C.** Animal Shelter Construction Update and Change Order #2. The Animal Shelter construction continued during the past month and remains on schedule. The site has been cleared, rough grading has taken place around the building pad, water and sewer lines have been installed to the site and across the property, footers have been poured and construction of the building has begun. It is anticipated that the building framing will be in place during the month of May with a planned completion in mid-August.

During the excavation for the water and sewer lines, the contractor encountered rock beyond the allowances and also was required by the City of Henderson to change the waterline material under Julia Avenue. These two changes necessitate approval of Change Order #2 adding \$13,743 to the construction contract. Following the previous deduction for removal of landscaping, the total budget impact of change orders to date is \$3,609 which will come from contingency. **Recommendation:** Approve Change Order #2 adding \$13,743 to the construction contract with Riggs Harrod Builders, Inc. for rock removal and changing the waterline material as required by the City of Henderson.

- **D. Fireworks Permit.** The Vance County Tourism Department is requesting approval of a fireworks permit for its annual Independence Day celebration at Kerr Lake. According to Tourism Director Nancy Wilson, the work will be contracted with a professional pyrotechnics firm which has the appropriate credentials and insurance coverage. **Recommendation:** Approve the request for a permit to discharge fireworks at its annual Independence Day celebration at Kerr Lake on July 2, 2015, contingent upon the contractor being adequately insured.
- **E. Abandoned Mobile Home Program.** The County has received \$12,000 in grant funds from the NC Department of Environmental Quality to facilitate the cleanup of abandoned mobile homes. The County has been very successful with this program in the past and cleaned up a total of 34 units in 2010 with a \$37,500 grant. The latest grant will allow the County to clean up 5 of the 11 county owned Real Estate Owned (REO) properties with remaining funds being available for additional cleanup throughout the county. **Recommendation:** Authorize the chairman to execute the abandoned mobile home grant agreement with NC DEQ.



#### Section II. AMH Program Description

Vance County intends to initiate an Abandoned Manufactured Home (AMH) abatement program in the 2015- 2016 fiscal year to assist both homeowners, in addition to Vance County owned properties (obtained via foreclosure), for the removal of abandoned manufactured homes. Vance County began its first AMH program in FY 2009-10 and was very successful in removing over 30 units under a previous grant. The Abandoned Manufactured Home Planning Initiative is designed to act as a management tool for the reduction, abatement, recycling and proper disposal of abandoned manufactured homes. The program indirectly offers a financial incentive to remove the units from properties located throughout Vance County, but also offers those who are not able to pay, free removal and disposal. Measures will be taken to ensure that all demolition debris are properly disposed of or recycled at designated and permitted facilities. The goal of the program is to improve the resale of properties owned by Vance County in addition to reducing the number of properties that pose a threat to the health, safety, and general welfare of the citizens of Vance County. Through proper demolition, removal, and recycling of abandoned manufactured homes, citizens enjoy the benefits of protected property values, increased safety, and environmentally friendly communities. Acceptance into the program is based upon funding availability, a site inspection, and the discretion of the Vance County Planning and Development Department. The legal basis for Vance County's AMH Program is found in Vance County Ordinance # 33 (Existing Buildings). The functional basis for Vance County to engage in an abandoned manufactured home cleanup program is found on Page 22 through Page 27 of the "Vance County Solid Waste Management Plan — July 1, 2009 – July 1, 2019"

## • An estimate or projection of the number of AMH units intended to be managed during the grant term and the length of grant term requested (one to two years).

Vance County has identified seven, (7) mobile homes obtained through the foreclosure. The county has identified up to nine (9) more possible units that may be a good fit for AMH cleanup during the life of the grant. Vance County is designated as a Tier 1 county by the NC Department of Commerce. For this grant cycle, we are requesting a term of two (2) years.

## • A description of the program approach to sharing the cost of deconstruction with responsible parties and a description of the process for recovery of funds from responsible parties.

Vance County will pay \$350.00/single unit for each of the properties that are deemed eligible for assistance. For individual owners, the county will require payment of the same prior to removal of the unit. If the property owner is unable to pay due to financial difficulties, no fee will be required. The income levels for waiver of fees are as follows:

One (1) person household	\$28,300
Two (2) person household	\$32,300
Three (3) person household	\$36,350
Four (4) person household	\$40,400
Five (5) person household	\$43,650

The \$ 350.00 payment of county assistance per unit comes out of the enterprise fund will not impact the budget for this grant activity. At this point, the county does not have enough information to determine who or how many abandoned manufactured homeowners will qualify for assistance.

Abandoned Manufactured Home (AMH) owners and landowners that do not meet the financial hardship criteria above will be charged a tipping fee by the county. This amount is typically \$250.00 if the unit is demolished intact (single wide cost) or \$ 42.00 per ton if demolished on site. Where responsible person has some financial means at their disposal, these persons may be required to pay a participation fee of \$ 210.00. This is to meet the criteria in the AMH application guidelines that homeowners who can pay a portion of cost of an abandoned manufactured home (AMH) demolition share in the cost of AMH removal. At this time, the county is uncertain how much money it could receive from the AMH owners that may qualify for the program, however, Vance County believes that many of them will not have the means to pay for AMH demolitions. If the county cannot directly collect fees from AMH owners, it does have the means to use liens upon sale of the property to recoup this cost, if it is deemed necessary. Voluntary and Involuntary demolitions will be conducted in accordance with the Written Plan on Page 6 through Page 9 of this document and Vance County Ordinance # 33. The county has budgeted a total \$ 14,800.000 for AMH grant demolitions in this grant application.

# • A description of the program approach to deconstruction operations. Will deconstruction activities be performed by county staff or a contractor? Will county staff oversee or supervise deconstruction activities? Will non-recycled deconstruction debris be directed to a specific facility for disposal?

The county will conduct its AMH project work on a bid award basis. In general, requests for proposals for demolition work on units will be advertised and awarded to the most responsible bidder that submits the lowest bid and meets the county's performance criteria for contracting services with Vance County. Once the contractor is awarded the project, the contractor must notify Vance County Planning and Development prior to the demolition, removal, and recycling of the abandoned manufactured home. Prior to demolition, pre-deconstruction meeting will be held with the contractor and the county staff to carefully assess the scope-of-work needed for each awarded job. A site survey must be conducted with a Vance County representative to identify recyclables and any utility connections including marking the placement of a septic tank and/or septic field and any hazards associated with the site (i.e. hazardous wastes, asbestos, lead paint, or worker hazards, etc.) if they exist.

When deconstructing units under the Vance County AMH Program, the following shall apply to abandoned manufactured homes whether completely intact or partially deconstructed:

- (1) All demolition activities will be conducted at the property, unless otherwise approved by Vance County;
- (2) The contractor shall attempt to remove any recyclable materials from the abandoned manufactured home prior to demolition. Recyclable materials are those items listed and discussed on Page 8 of the Written Plan for this state grant.
- (3) The contractor shall deconstruct the home in a manner to minimize airborne debris.
- (4) The demolition debris shall be contained on-site in a manner that would not cause any adverse effects to adjoining properties, where the demolition is preformed on-site.
- (5) All materials must be delivered to a permitted landfill or recycling center.
- (6) The contractor will cap off all water/septic lines.

The deconstruction contractor will provide the landfill receipt(s) and recycled tonnage data to the Vance County Planning and Development office upon completion. The deconstruction process shall be carried out in a manner that poses the least amount of disturbance or damage to the subject property.

The demolition contractors are required to level, compact, or fill any portion of the property that is affected by the deconstruction and removal of debris. The contractor shall take all measures possible to minimize any unnecessary disturbance of soil or vegetation on the property. The contractor is required to remove and replace any contaminated soil that results from the spillage of any fluids or hazardous materials from equipment associated with performing the demolition or removal of debris.

The demolition contractor shall provide and maintain a level of insurance that will cover any damage or injuries that may occur to property or persons while performing the service of demolition and removal of the abandoned manufactured home. Vance County shall be noted in a hold harmless agreement and added to the contractor's insurance policy as additionally insured. The contractor is responsible for any damage that may occur to the property that is outside the specified area of demolition. The contractor and any of the contractor's employees, act as agents of the company and not as an agent of the County. The County shall not be held liable for any actions or damage that may occur as a result of the demolition and removal of an abandoned manufactured home.

## • A plan for meeting basic recycling requirements when managing AMH units, at a minimum including the recycling of all metals, including siding, roofing, chassis, and window frames.

Demolition wastes and recycled materials will be managed in accordance with "Vance County Solid Waste Management Plan (July 1, 2009-June 30, 2019)". During initial meeting with contractor, county staff will identify what materials need to be recycled and/or reused as shown on Page 8 of the Written Plan of this grant application. Identified items must be sorted and delivered to an appropriate recycling center. County staff will check to ensure proper management of recyclables on each site visit. Contractors will be required to submit documentation on materials recycled with invoice for deconstruction services. Vance County and selected contractors may utilize the following metals recyclers. #### A plan for removal and proper management of mercury thermostats.

All thermostats located within the homes will be removed by the contractor and packaged to prevent damage during the deconstruction process. The contractor will provide verification of removal and destination of such materials. Contractors are to report the removal and recycling of mercury switches or other hazardous materials located within the homes. Contractor will contract with Safety Kleen Systems, Inc. of Raleigh to address mercury containing products.

#### • A plan for the removal and proper management of fluorescent lights.

The procedure our contractors must use per county directives for the management of fluorescent lights (i.e. tubes, CFLs, mercury lamps, etc.) is the same as for other mercury containing products shown above for thermostats whereas the same contractor will be used.

## • A plan for the removal and proper management of white goods, tires and other materials banned from disposal in North Carolina.

Vance County staff will conduct a walk through to be sure all white goods, tires and other materials banned from the landfill will be removed, segregated, and/or recycled. White goods will be given to the contractor, whereas refrigerant will be properly removed prior to recycling. Tires will be taken to Vance County Tire Site where they will be picked up by Central Carolina Holdings for recycling. Again, documentation will be provided by the contractor for white goods, tires and other materials.

# A plan for gathering and tracking program data including the number of units managed and the tonnage and types of materials recycled and disposed for each unit (data on materials landfilled and recycled is required to be included for each project when seeking reimbursement of grant funds).

The County will utilize a spreadsheet to monitor the progress of the program. A complete log of project data is recorded into the system. Information pertaining to project expenditures and revenues as well as disposal and recycling amounts are accessible through this spreadsheet. The spreadsheet enables Vance County to submit reports, a fiscal year report on the grant's progress, support reimbursement requests, and assist in developing information for a final report to the North Carolina Department of Environmental Quality. For materials recycled or disposed of, the county will require contractors to provide receipts of tip fees and weights of these materials for every unit deconstructed and removed.

This information will be kept at Vance County Planning Services and be available to the state staff upon request. Additionally, The County will keep "before and after photos" of each deconstruction and keep this as part of its records as well.

#### Section III. Grant Implementation Timeline for AMH Program (May 2016 - May 2018):

- May 15, 2016: Initiate AMH Grant Program Operations and Deconstruction Activities;
- May 14, 2018: Final Report with final reimbursements approved by DEACS

#### Section IV. Program Budget (2-Year Grant Cycle / Total Funding \$ 12,000):

The following tables project estimated expenditures and revenues for the Vance County AMH Program during the term of the grant. Vance County hopes to run the AMH Program in a "revenue-neutral fashion". The projected expenditures are based on prior experience during earlier AMH grants, and the projected revenues assume that Vance County is able to collect a majority of the owners paid portion. Actual program expenditures and revenues may vary. Vance County being designated as a Tier 1 County, respectfully requests the maximum allowed amount of \$ 12,000 in grant funding. The following budget information is based on the anticipated removal of up to eight (8) abandoned manufactured homes consisting of singlewides and doublewides.

Revenue from the sale of recyclables are kept by the contractor but payment for deconstruction services is held after supplying necessary documentation showing pounds recycled of each material. This is shown to be most effective in encouraging recycling in the deconstruction process. The county disposal fee is \$ 42.00 for debris from demolished units and \$ 250.00 per unit, if a full AMH unit is delivered to the county intact.

#### Section V. Written Plan for the Management of Abandoned Manufactured Homes

## • Method by which the Vance County proposes to identify abandoned manufactured homes in the county ...:

Vance County believes it has an adequate number of abandoned manufactured homes (AMHs), of which the demolition could be supported by grant funding, have already identified. These seven (7) of the AMH's have already been identified by the County's foreclosure process. Any other AMH owners of abandoned and dilapidated manufactured homes will be identified through an inspection in conformance to regulations set forth in Section 13 of Vance County Ordinance #33. The county believes at this point, there could be as many as nine other possible abandoned and dilapidated properties of which any one of them could come under AMH grant program funding. The process of identifying the owners of the abandoned mobile homes will be as follows:

- > Conduct a property search to determine the owner of the real property.
- > Conduct a real property and/or personal property search to determine the ownership of the abandoned mobile home unit, including information from the NC DOT.
- ➤ Upon determining real or personal property ownership, the potentially responsible party will be issued written notice in accordance with NCGS 130A-309.114 and Vance County Ordinance #33.

In addition to the inspection guidelines in Section 13 of Vance County Ordinance #33, a representative from the department may also inspect properties at the request of the property owner(s) for the purpose of applying for assistance to voluntarily remove an abandoned or dilapidated manufactured home.

The inspection will be performed by Vance County Planning and Development representatives in order to verify the status of a manufactured home. If the inspection reveals that the criteria of an abandoned or dilapidated manufactured home are present, the home will be declared as such.

#### • A plan for the deconstruction of these abandoned manufactured homes:

Through the Request for Proposals (RFP) process, Vance County Planning and Development will notify all interested and authorized contractors of the bidding process for the demolition, removal, and recycling of abandoned manufactured homes. Contractors may be notified via US Postal Service (USPS) mail, electronic mail or fax for a request to submit bids. Contractors will be notified of the property location, ownership, and contact information and may contact the property owner(s) in order to obtain information necessary to submit a bid for the demolition, removal, and recycling of the manufactured home. Vance County Planning and Development will accept bids by authorized contractors that are received via USPS mail, electronic mail or fax. The contractor awarded the project will be notified via telephone by an authorized agent of the county. The Request for Proposal (RFP) will be the contract between said contractor and Vance County for the demolition and removal of the AMH. To ensure proper demolition, removal, and recycling methods are taken, only approved and licensed demolition contractors are eligible to provide deconstruction services. To minimize damage to surrounding property during deconstruction, only the approved demolition contractors with a Vance County Demolition permit will be eligible to remove and recycle debris under this program. Contractors are approved based on the ability to perform required deconstruction requirements. Approved demolition contractors must have the ability to deconstruct the abandoned manufactured home on-site or at a designated deconstruction site. All hazardous materials must be removed from the structure prior to deconstruction. Any such materials must be properly removed from the demolition site and transported to a center licensed to receive such materials. Contractors must agree to the terms and procedures specified within the RFP prior to performance of any services that may be assigned by the Vance County Planning and Development Department.

Approved demolition contractors will operate under a bid or request for proposals process. The following guidelines are set forth by Vance County to serve as standard operating procedures for the demolition and recycling of abandoned or dilapidated manufactured homes for voluntary or involuntary demolitions:

#### **➣** Site Survey for Voluntary Demolitions

Once the contractor is awarded the project, the contractor must notify the property owner(s) prior to the demolition, removal, and recycling of the abandoned manufactured home. A site survey must be conducted with the property owner(s) present to identify any utility connections including marking the placement of a septic tank and/or septic field. The property owner(s) is responsible for ensuring that all utility connections are disconnected and notifying the contractor when such measures have been taken. The contractor must be notified by the property owner(s) of any possible hazards. The contractor may not access the property through an adjoining property without proper consent from that property owner.

#### > Involuntary Demolitions in accordance with Vance County Ordinance #33:

As established in Ordinance #33 (Existing Buildings), when a petition is filed with Vance County Planning and Development Inspector by a unit of local government or by at least five (5) residents of the County, charging that any manufactured home is unfit for human habitation or use, he may in accordance with inspection criteria in the ordinance issue a complaint. Whenever it appears to the responsible local government staff, upon inspection, that a manufactured home is unfit for human habitation or use, he shall, issue a complaint stating the charges and containing a notice that a hearing will be held before the Inspector at a place therein fixed, not less than ten (10) nor more than thirty (30) days after the serving of the complaint. The findings in a preliminary investigation establishes and discloses the basis for making such a charge. The owner or any party in interest shall have the right to file an answer to the complaint and to appear in person, or otherwise, and give testimony at the place and time fixed in the complaint. Notice of such hearing shall also be given to at least one of the persons signing a petition relating to such dwelling. Any person may attend such hearing and give evidence relevant in courts of law or equity. The North Carolina Rules of Evidence shall not be controlling in these hearings. The inspector for Vance County will make a determination in writing if the manufactured home meets the criteria of "unfit for human habitation or use", and, if so, whether it is deteriorated or is dilapidated. Ordinance # 33 defines these terms as follows:

- (1) Deteriorated. If the inspector determines that the manufactured home is deteriorated, he shall state in writing his findings of fact in support of such determination, and shall issue and cause to be served upon the owner thereof an order directing and requiring the owner to repair, alter, improve or otherwise abate such home to comply with the minimum standard of fitness established by this ordinance within a specified period of time, not to exceed ninety (90) days. The order may also direct and require the owner to vacate and close such home until such repairs, alterations, and improvements or corrections have been made.
- (2) Dilapidated. If the inspector determines that the manufactured home is dilapidated, he shall state in writing his finding of fact to support such determination, and shall issue and cause to be served upon the owner thereof an order directing and requiring the owner either to repair, alter, improve or otherwise abate such conditions as to comply with the minimum standards of fitness established by this ordinance, or else to vacate and remove or demolish the same within a specified period of time not to exceed ninety (90) days.

If an abandoned or dilapidated manufactured home is not removed, abated or remedied during the time frame provided by the inspector, the county may enter into an enforcement action against the AMH owner or landowner and be carried out according to Vance County Ordinance #33. As authorized by NCGS 153A-140 and Vance County Ordinance #33, the county may enter the property and remove, abate or remedy everything related to the abandoned manufactured home that is "dangerous or prejudicial" to public health and safety. The expense shall be a lien against the real property upon which such expense was incurred.

## • A plan for the removal of deconstructed components, including mercury switches and thermostats, for reuse or recycling as appropriate;

As stated before, contractor will segregate all recyclables from the disposable material. If structurally sound, the mobile home will be moved whole to the Granville County Landfill (Permit No. 39-01) where it is deconstructed on the working face of the landfill. At that time, axles and tires can be taken for recycling. However, if the mobile home cannot be moved safely, it will be deconstructed onsite per above mentioned requirements.

With respect to deconstruction of abandoned manufactured homes (AMHs), the following shall apply to abandoned manufactured homes whether completely intact or partially deconstructed. The contractor shall attempt to remove any recyclable materials from the abandoned manufactured home prior to demolition. Recyclable materials may include but are not limited to: metals, glass, wood, plastics, and thermostats containing mercury switches. The contractor shall deconstruct the home in a manner to minimize airborne debris. The demolition debris shall be contained on-site in a manner that would not cause any adverse effects to adjoining properties. All materials must be delivered to a certified landfill or recycling center. The deconstruction process shall be carried out in a manner as to cause the least amount of disturbance or damage to the subject property.

Removal of all demolition debris from the site shall be performed by a vehicle capable of safely transporting materials from the demolition site to a certified landfill or recycling center. During transportation, all debris must remain covered with a tarp or fabric and shall be properly secured, so as not to allow any debris to fall from the vehicle. All debris from any of the deconstructed components must be removed from the property. Contractors must supply Vance County with verification of removed materials illustrating the amount, type, and destination of all items generated from the site. The demolition contractors are required to level, compact, or fill any portion of the property that is affected by the deconstruction and removal of debris. The contractor shall take all measures possible to minimize any unnecessary disturbance of soil or vegetation on the property. The contractor is required to remove and replace any contaminated soil that results from the spillage of any fluids or hazardous materials from equipment associated with performing the demolition or removal of debris. A site inspection shall be conducted by a Vance County Planning and Development Department representative to verify deconstruction of the abandoned manufactured home (AMH) and that the current lot conditions meet the expectations of the county. A photograph is taken to illustrate the site before and after the project is completed. The contactor is responsible for following grant contract conditions in disposing of debris from an AMH demolition. That person is responsible to make sure he follows all applicable local, state, and federal ordinances, rules, regulations, guidelines, laws and statutes regarding the proper disposal of these materials and the county program will make him aware of these responsibilities prior to work begin done at a site.

All hazardous materials must be removed from the structure prior to deconstruction. Any such materials must be properly removed from the demolition site and transported to a center licensed to receive such materials. Mercury switches and fluorescent lighting fixtures will also be removed and turned over to the proper recycling company and report on this to county AMH staff. Any special

wastes encountered at an AMH demolition site (such as tires, white goods, lead-acid batteries, used motor oil, household hazardous wastes, pesticides, or other wastes) will be handled pursuant to the methods outlined in the recent three- year update of Vance County's 10-year Solid Waste Management Plan. This plan is identified in county records as "Vance County Solid Waste Management Plan — July 1, 2009 – July 1, 2019". Most of these materials, particularly metals and white goods, will be managed at the Granville County Landfill (Permit Number 39-01, 6584 Land Fill Road, Oxford, NC 27565; 919-603-1355. Scrap tires are sent to Central Carolina Holdings LLC.

#### A plan for the proper disposal of abandoned manufactured homes not deconstructed:

Manufactured home deemed abandoned and not deconstructed may be subject to actions specified in county ordinances and state law. All homes deconstructed in Vance County must conform to the requirements of county ordinances and state rules for solid waste and Vance County Planning and Development Program. This is regardless of whether or not the county or the owner of the abandoned manufactured home (AMH) managed or initiated the demolition project. Work performed with respect to these AMH demolitions must be consistent with the guidance contained in the Vance County Solid Waste Management Plan and comply for county ordinances. Any actions taken by persons to cause or contribute to a violation may be addressed by legal actions.

Note on Documents Referenced in this Grant Application: The county ordinance, county solid waste management plan, and North Carolina General Statute noted on various pages in this grant application are all "incorporated by reference" to support the Vance County Grant Application and will be held on file at the county offices. This document may be made available to the public and is subject to Vance County's public access requirements.
