The Vance County Board of Commissioners met in regular session on Monday, December 3, 2012 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairman Terry E. Garrison, Commissioners Thomas S. Hester, Jr., Deborah F. Brown, Dan Brummitt, Archie B. Taylor, Jr., Gordon Wilder, and Eddie L. Wright. Absent: None.

Also present were County Manager Jerry L. Ayscue, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom

Commissioner Eddie L. Wright gave the invocation.

Before the meeting began, Judge Henry W. Hight, Jr. administered the oaths of office for newly elected Commissioner Archie B. Taylor, Jr., and three re-elected Commissioners -Commissioner Deborah F. Brown, Commissioner Eddie L. Wright, and Commissioner Terry E. Garrison.

The first order of business was the election of the Chairman. Commissioner Eddie L. Wright nominated Commissioner Thomas S. Hester, Jr. for the position of Chairman. Commissioner Deborah F. Brown seconded the nomination. Motion was made by Commissioner Deborah F. Brown, seconded by Commissioner Gordon Wilder, to close the nominations. Vote to close the nominations and appoint Commissioner Thomas S. Hester, Jr. as Chairman for the coming year was unanimous.

The next order of business was the appointment of the Clerk to the Board. Motion was made by Commissioner Eddie L. Wright to appoint Kelly H. Grissom to the position of Clerk to the Board for the coming year. This motion was seconded by Commissioner Deborah F. Brown and unanimously approved.

Commissioner Terry E. Garrison moved to appoint Commissioner Deborah F. Brown to the position of Vice-Chairman. This motion was seconded by Commissioner Eddie L. Wright and unanimously approved.

The next order of business was the appointment of County Manager. Motion was made by Commissioner Eddie L. Wright to appoint Jerry L. Ayscue to the position of County Manager for the coming year. This motion was seconded by Commissioner Terry E. Garrison and unanimously approved.

Commissioner Terry E. Garrison moved to appoint Jerry L. Ayscue as Interim Finance Officer. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Motion was made by Commissioner Eddie L. Wright to appoint Jonathan S. Care to the position of County Attorney for the coming year. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Motion was made by Commissioner Terry E. Garrison, seconded by Commissioner Deborah F. Brown, vote unanimous, that the following officials be appointed for a one-year term: Brad Weatherington, Custodian of the Courthouse, the County Administration Building, and the County Office Building; Sandra Grissom, Custodian of the Henry A. Dennis Building; and Linda Fry, Custodian of the Social Services Building.

Chairman Thomas S. Hester, Jr. requested that this information be put online. Commissioner Dan Brummitt requested that state road numbers be cross-referenced with the road names. Commissioner Archie B. Taylor, Jr. asked how it is determined which roads are to be paved. Mr. Winstead responded that unpaved roads are evaluated every four years and prioritized by traffic count, the number of homes and/or businesses on the road, school routes, acquisition of rights of way, etc. The roads are then prioritized by these factors.

Ms. Geraldine Fuller asked how to get a road sign repaired that has been down for several months, just over the county line in Warren County. Mr. Winstead stated that she should contact the Warren County Planning Department.

As there was no one else who wished to speak on the matter, Chairman Hester declared the public hearing closed.

Motion was made by Commissioner Eddie L. Wright to approve the 2012-13 Secondary Road Program as presented. This motion was seconded by Commissioner Terry E. Garrison and unanimously approved.

At this time, Chairman Hester publicly thanked Commissioner Garrison for his work this past year as Chairman. He also congratulated Commissioners Brown, Garrison, and Wright on their re-election as well as newly elected Commissioner Taylor for his interest in county government.

Chairman Hester stated that his top priorities for the coming year include job creation, no increase in taxes, and responsible fiscal management. Other priorities include continuation of the water project and planning of a new animal shelter. He also asked that the Board be presented its budget on May 1st. He stated that he looks forward to the coming year as Chairman.

The Board of Commissioners for the County of Vance, North Carolina, met in a regular meeting in Commissioners' Meeting Room at the Vance County Administration Building located at 122 Young Street in Henderson, North Carolina at 6:45 p.m. on December 3, 2012.

Present: Chairman Thomas S. Hester, Jr., presiding, and Commissioners Deborah F. Brown, Dan Brummitt, Terry E. Garrison, Archie B. Taylor, Jr., Gordon Wilder, and Eddie L. Wright.

Absent: None

Also present: County Manager Jerry L. Ayscue, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

The Chairman announced that this was the hour and day of the public hearing on a proposed installment financing agreement to be entered into by the County of Vance, North Carolina (the "County") pursuant to Section 160A-20 of the General Statutes of North Carolina in an amount not to exceed \$2,000,000 for the purpose of providing funds, together with any other available funds, to pay the costs of renovating, improving and equipping various public school facilities in the County, including, without limitation, Aycock Elementary School, Dabney Elementary School, Zeb Vance Elementary School, E.O. Young Elementary School, Carver Elementary School, L.B. Yancey Elementary School, Eaton-Johnson Middle School, Henderson Middle School and Northern Vance High School (collectively, the "Project"). The

Chairman also announced that this was the hour and day of the public hearing on the proposed acquisition by the County of all or a portion of the sites of the Project for use by the Vance County Board of Education for school purposes pursuant to Section 153A-158.1 of the General Statutes of North Carolina.

The Chairman acknowledged due publication of a notice of public hearing in a newspaper with general circulation in said County as required by Section 160A-20 and Section 153A-158.1 of the General Statutes of North Carolina and directed the Clerk to the Board to attach the affidavit showing publication in said newspaper on a date at least ten (10) days prior to the date hereof as Exhibit A hereto.

The Chairman then announced that the Board of Commissioners would immediately hear anyone who might wish to be heard on the advisability of the proposed Project, financing or acquisition as described above.

As there was no one who wished to speak on the matter, Chairman Thomas S. Hester, Jr. declared the public hearing closed.

Thereupon, Chairman Hester introduced the following resolution:

RESOLUTION MAKING CERTAIN FINDINGS AND DETERMINATIONS REGARDING THE FINANCING OF THE RENOVATION, IMPROVMENT AND EQUIPPING OF PUBLIC SCHOOL FACILITIES BY THE COUNTY PURSUANT TO AN INSTALLMENT FINANCING AGREEMENT AND REQUESTING THE LOCAL GOVERNMENT COMMISSION TO APPROVE THE FINANCING ARRANGEMENT

BE IT RESOLVED by the Board of Commissioners (the "Board") for the County of Vance, North Carolina (the "County") as follows:

Section 1. The Board does hereby find and determine as follows:

(a) There exists in the County a need to renovate, improve and equip certain public school facilities of the County.

(b) After due consideration, the County has determined to enter into an installment financing agreement (the "Agreement") in the aggregate principal amount not to exceed \$2,000,000 to pay the costs of renovating, improving and equipping various public school facilities in the County, including, without limitation, Aycock Elementary School, Dabney Elementary School, Zeb Vance Elementary School, E.O. Young Elementary School, Carver Elementary School, L.B. Yancey Elementary School, Eaton-Johnson Middle School, Henderson Middle School and Northern Vance High School (collectively, the "Project").

(c) The County will enter into the Agreement with a financial institution to be selected by the County with the advice of bond counsel and the County Attorney (the "Lender"), pursuant to which the Lender will advance to the County amounts sufficient to pay the costs of financing the Project, and the County will repay the advancement in installments (the "Installment Payments").

(d) In order to secure the Installment Payments, the Agreement will grant a lien on the site of the Zeb Vance Elementary School (the "Site"), together with all buildings, improvements and fixtures located or to be located thereon.

(e) It is in the best interest of the County to enter into the Agreement in that such transaction will result in providing financing for such Project in an efficient and cost effective manner.

(f) Entering into the Agreement is preferable to a general obligation bond and revenue bond issue in that (i) the County does not have the constitutional authority to issue non-voted general obligation bonds pursuant to Article V, Section 4 of the North Carolina Constitution because the County has not retired a sufficient amount of debt in the preceding fiscal year to issue a sufficient amount of general obligation bonds for the Project without an election; (ii) the nature of the financing does not allow for the issuance of revenue bonds; (iii) the cost of the Project exceeds the amount to be prudently provided from currently available appropriations and unappropriated fund balances; (iv) the circumstances existing require that funds be available to commence construction of the Project as soon as practicable and the time required for holding an election for the issuance of voted general obligation bonds pursuant to Article V, Section 4 of the North Carolina Constitution and the Local Government Bond Act will delay the commencement of construction of the Project by several months; and (v) there can be no assurances that the Project will be approved by the voters and the necessity of such Project dictates that the Project be financed by a method that assures that such Project will be constructed in an expedient manner.

(g) It has been determined by the Board that the cost of financing the Project through an installment financing agreement is reasonably comparable to the costs of issuing general obligation bonds or other available methods of financing and is acceptable to the Board.

(h) Counsel to the County will render an opinion to the effect that the proposed undertaking as described above is authorized by law and is a purpose for which public funds may be expended pursuant to the Constitution and laws of the State of North Carolina.

(i) The debt management policies of the County have been carried out in strict compliance with law, and the County is not in default under any obligation for repayment of borrowed money.

(j) Any tax rate increase necessary to pay the Installment Payments will be reasonable and not excessive.

(k) This financing will qualify as a "qualified zone academy bond" financing with the meaning of Section 1397E of the Internal Revenue Code such that interest subsidy payments will be paid to the County by the United States government in an amount equal to all or some portion of the interest component of the Installment Payments under the Agreement, and the total financing cost to the County is expected to be less than it would have been under a traditional installment financing arrangement.

Section 2. The Board hereby authorizes, ratifies and approves the filing of an application with the Local Government Commission for approval of the Agreement and requests the Local Government Commission to approve of the Agreement and the proposed financing in connection therewith.

Section 3. This resolution shall take effect immediately upon its passage.

County Manager's Report

CDBG Award of Bids. Mr. Ayscue reported that according to previous authorization from the Board of Commissioners, the County Manager has awarded construction bids for rehabilitation of two houses under the CDBG Scattered Site Program to the low bidders as follows:

Motion was made by Commissioner Terry E. Garrison to approve the low bidders as follows: AWE Home Repair - \$19,500; and L. Roberts Home Repair - \$27,785. This motion was seconded by Commissioner Eddie L. Wright and unanimously approved.

Thermo King Water Line Extension. County Manager Jerry L. Ayscue noted that the County has approved the extension of a water line to Thermo King, Inc. on Crawley Road. Grants from the NC Rural Center and the Golden LEAF Foundation have been secured, with the County and City sharing the local match requirements. Due to an adjustment in the grant amount from the Rural Center, an additional \$3,040 is needed from the County in order to cover project costs. An additional \$1,013 will be sought from the City. Mr. Ayscue recommended that the Board appropriate \$3,040 from the Contingency in order to proceed with the Thermo King water line extension.

Motion was made by Commissioner Terry E. Garrison to appropriate \$3,040 from the Contingency in order to proceed with the Thermo King water line extension, contingent upon the City's contribution of \$1,013. This motion was seconded by Commissioner Eddie L. Wright and unanimously approved.

Schedule for Annual Planning Retreat. Mr. Ayscue noted that the Board of Commissioners' annual planning retreat is usually held in late January. Due to the NCACC Legislative Conference that is to be held on January 24–25, Commissioners may wish to schedule the planning retreat on or around January 17 (Thursday) or perhaps even in mid-February. The Board scheduled its annual planning retreat for Thursday, January 17, 2013.

Audit Contract Extension. Mr. Ayscue stated that work continues on preparation of financial statements for the County's audit report for FY 2011-12. An additional thirty days are needed to complete the report.

Motion was made by Commissioner Gordon Wilder to authorize the Chairman to execute a thirty-day extension to the County's existing audit contract. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Pending Business

VFD Contracts and Audits. Mr. Ayscue reported that contact was made with Epsom VFD and it was verified that they are waiting for the CPA firm to complete their audit report. The County Manager spoke with the auditor and confirmed the situation. This is the same situation with Drewry VFD.

Commissioner Deborah F. Brown asked that a written statement be obtained from the CPA firm regarding this matter. Commissioner Dan Brummitt questioned if the timeframe established by the Board of Commissioners needs to be revised for future audit reports. Mr. Ayscue stated that he would look into this matter and report back to the Board.

At this time, Commissioner Deborah F. Brown excused herself from the meeting in order to attend another obligation at Vance Granville Community College.

County Water Project. Phase 1A. Water line construction work methodically continues throughout Phase 1A approved areas. During November (through the 28th), an additional 23 sign-ups were received. As of November 28, a total of 819 customers have been enrolled, and there are 14 additional dry taps. Engineers and staff are working together to identify and prepare additional roads for extension of lines. Site preparation work has begun at the tank site along Warrenton Road. Line construction continues along Vicksboro Road as well as other areas. The rate of construction continues to be slowed by rock that has been encountered on several roads. Work crews have begun to install water taps and meter boxes along a portion of the installed lines areas. County staff is delivering letters and pin flags to those who have purchased a tap for installation of the meter boxes. Monthly construction meetings are held to coordinate on various issues with construction, safety, billing, traffic control, etc. *Phase 1B.* USDA Rural Development and Kittrell Water Association continue to work together to seek funding for Phase 1B, consistent with action taken by the Commissioners in December 2009. *Phases 2A & 2B.* Funding from USDA Rural Development has been established for both of these phases. Phase

2A will be funded with \$2.2 million in loans and \$1.62 million in grants. Phase 2B has \$3.94 million in loans and \$1.99 million in grants. The Board of County Commissioners and the Water District Board approved the water purchase/sales agreement with the City of Henderson on July 23, 2012. USDA Rural Development subsequently approved the agreement. USDA Rural Development has been notified that the ARRA funds must be spent on an accelerated schedule with construction beginning by September 30, 2012, unless a waiver is obtained. This represents a three-year difference in time (previously September 30, 2015). An extension (waiver) request regarding the deadline was submitted to USDA Rural Development to ensure that the project can be appropriately completed in the spring. District and state USDA RD officials are highly supportive of granting an extension, but the final decision is to be made at the federal level. Thus far, the County has not received notification of waiver approval. Local and state USDA RD staffs encourage the County to continue to proceed as expeditiously as possible. Project design is complete and has been submitted to the appropriate regulatory agencies. The City of Henderson, USDA RD, and the County's engineers are currently reviewing the project plans. Public Water Supply Section of DENR is currently reviewing the permit applications which were submitted on October 29. Erosion and Sedimentation Control permits have been approved. Requests for approval of encroachment agreements were submitted to NCDOT in September. Submission of application information to USDA Rural Development is currently being done for both phases. Sites for the water tank and one meter vault in the area covered by Phase 2A and 2B have been approved by the Schools System. Negotiations have taken place with two additional property owners for two meter vault sites and options to purchase are currently being processed. Engineers are pursuing a lake crossing permit and a Kerr Lake Reservoir utility crossing easement through the U.S. Army Corps of Engineers. There are some low pressure concerns in the Poplar Creek Road area that are being studied and addressed. Due to the timing of the funding of Phases 2A & 2B, it will be important that work on these phases begin as soon as possible. The approved O&M services contract will cover Phases 2A and 2B in addition to 1A. Additional sign-ups remain essential in Phases 2A and 2B due to the current lack of substantial customer concentration. The engineering firm is working on a sign-up analysis of both phases. Current sign-up totals are 361 for Phase 2A and 364 for Phase 2B.

The Board asked the County Manager to provide information on the extra costs associated with encountering rock.
