#### COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, July 9, 2012 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairman Terry E. Garrison, Commissioners Thomas S. Hester, Jr., Deborah F. Brown, Dan Brummitt, J. Timothy Pegram, Gordon Wilder and Eddie L. Wright.

Absent: None.

Also present were County Manager Jerry L. Ayscue, Finance Director Steven C. Stanton, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Chairman Terry E. Garrison gave the invocation.

The first item on the agenda was the annual meeting of the Composite Board consisting of the Board of Commissioners, the Chairman of the Board of Education and the Mayor of the City of Henderson. Ms. Gloria White, Chair of the Board of Education, and Mayor Pete O'Geary were both absent.

It was noted that Mr. John Fogg had submitted a letter seeking re-appointment to the Vance County ABC Board for a three-year term. Ms. Nancy Wilson had submitted a letter requesting to be re-appointed as Chair for a one-year term. No other applications were received. Although Mayor O'Geary was unable to attend the meeting, he did submit a letter affirming his support of the reappointments as requested.

Motion was made by Commissioner Thomas S. Hester, Jr. to re-appoint John Fogg to the Vance County ABC Board for a three-year term and re-appoint Nancy Wilson as Chair for a one-year term. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Stuart Litvin, Economic Development Director, was next on the agenda and introduced the North Carolina Deputy Secretary of Commerce, Mr. Dale Carroll. Mr. Carroll recognized Vance County for completing Version 3.0 of the Statewide Certified Industrial Site Program for not one, but two certified sites. He stated that this is very special for any community inside North Carolina. The two sites are the Triangle North Vance Commerce Park and the Henderson-Vance Industrial Park. On behalf of the Department of Commerce and the State of North Carolina, Mr. Carroll presented two plaques to the Board recognizing these accomplishments.

On behalf of the Board of Commissioners, Chairman Garrison thanked Mr. Carroll for taking the time to come to Vance County to present the certification plaques and stated that it is an honor to be recognized in this capacity.

At this time, Chairman Garrison recognized Mr. Sam Haithcock as the Interim DSS Director.

Mr. Haithcock stated that it is a pleasure to be in Vance County until the DSS Board appoints a new director. He asked the Board to call on him at any time.

Public comments were heard next. Ms. Henrietta Clark spoke in support of the STEM Program and asked the Board to do all it can to promote this program and help the students of Vance County.

### County Manager's Office

Resolution of Appreciation. Mr. Ayscue stated that after over 24 years of service, Mr. Randy Ball has officially retired as Soil & Water Technician for the Vance County Soil & Water Conservation District. He requested the Board to adopt a resolution recognizing Mr. Ball.

Mr. Ball thanked the Board for this honor and stated that it has been a pleasure to work for the County over the years. He also recognized his wife and two sons that were present.

Contracts for VFDs and Rescue Squad. Mr. Ayscue explained that as discussed during budget work sessions, it is necessary to enter into new contracts with the Volunteer Fire Departments and the Rescue Squad. The contracts address various items of interest as expressed by the Board. The Public Safety Committee, Fire Marshal, County Attorney, and County Manager have reviewed the contracts. He recommended approval of the contracts for the Volunteer Fire Departments and the Vance County Rescue Squad as endorsed by the Public Safety Committee and authorize the Chairman to execute them.

Commissioner Dan Brummitt asked that wording be changed in reference to adhering to guidelines established by the City of Henderson when using fire hydrants. Since there are other water entities involved (the County and the Kittrell Water Association), verbiage should be changed to "the appropriate water entity" rather than "the City of Henderson". Also, Mr. Ayscue explained that VFDs follow different fiscal years, and suggested that the section referring to VFDs submitting annual audit reports in October should be changed to the last working day of the appropriate fiscal year. The Board agreed to these changes as well as some minor typo-graphical errors.

Commissioner Deborah F. Brown asked for a list of each department's fiscal year in order to be entered into the record. She also asked for initial information regarding how record keeping will be handled for each department. Chairman Garrison requested progress reports from each department.

After further discussion, motion was made by Commissioner Dan Brummitt to approve the contracts with the Volunteer Fire Departments with the changes discussed. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Motion was made by Commissioner Thomas S. Hester, Jr., seconded by Commissioner

Deborah F. Brown, vote unanimous, to approve the contract with the Rescue Squad as presented

with similar changes to be consistent with the Volunteer Fire Department contracts.

Economic Development Project Agreement. Mr. Ayscue noted that the Board of

Commissioners committed to provide a local incentive to Semprius, Inc. in the form of an economic

development grant as a means of recruiting the company to Vance County. The formal document

was presented to the Board and approval of the agreement was requested.

County Attorney Jonathan S. Care provided highlights of the agreement and stated that he

has prepared the agreement in a manner that protects the County as much as possible. He noted that

Semprius has signed the document without any changes.

Motion was made by Commissioner Gordon Wilder to approve the agreement with Semprius

for job creation and economic development as presented. This motion was seconded by

Commissioner Thomas S. Hester, Jr.

Commissioner Dan Brummitt asked how this agreement parallels with the performance

requirements established by the other entities involved in this project. Mr. Care responded that the

performance requirements for the other grants are all job based. The agreement before the Board

tonight is job based and ad valorem tax investments, both in personal property and real property.

Commissioner Deborah F. Brown asked if language could be included in this contract that

states that every effort will be made to fill these jobs with Vance County residents, and also utilize

Vance Granville Community College with training efforts. Attorney Care responded that the reason

such language is not included in this agreement is because it is already a vital part of the CDBG

agreement. He assured the Board that the County is well protected.

Vote to approve the agreement with Semprius for provision of local economic development

grant incentives in return for creation of jobs and increase in the County's property tax base was

unanimous.

Committee Reports and Recommendations

Human Resources Committee - Position Vacancies. Mr. Ayscue requested authorization to

Motion was made by Commissioner Eddie L. Wright, seconded by Commissioner Dan Brummitt, vote unanimous, to approve the position requests as presented.

Planning & Environmental Committee - NSP Marketing Services. Mr. Ayscue reported that this Committee met earlier today to review responses to the Request for Proposals (RFP) for provision of marketing/real estate services for the Neighborhood Stabilization Program (NSP). The Board of Commissioners previously delegated authority to the Committee to implement such a strategy to sell NSP homes to buyers as identified in the NSP regulations. The Committee recommends that Century 21 Country Knolls Realty be selected as the real estate professional to market these homes.

Motion was made by Commissioner Deborah F. Brown, seconded by Commissioner Dan Brummitt, vote unanimous, to select Century 21 Country Knolls Realty to market the homes under the Neighborhood Stabilization Program.

Planning & Environmental Committee - Permit Fees for Non-profits. Mr. Ayscue stated that the Committee reviewed a proposal to exempt approved non-profits from payment of permit fees for handicapped ramps and roofing shingle replacement projects. The Committee did not support waiving these fees for all non-profits, but supports the option for waiver requests to be addressed on a case-by-case basis.

Planning & Environmental Committee - E-Waste Recycling Program. Planning Director Jordan McMillen presented a proposed change to the Committee regarding the e-waste recycling program. Mr. McMillen explained that the County contracted with American Greenz last June to handle electronic waste. Pods are located at the Brodie Road and NC 39 Hwy sites for this purpose. He stated that the County receives funds from DENR based upon the amount of e-waste that is generated. Beginning next year, the company contracted with must be certified, and American Greenz is not certified. Mr. McMillen stated that as we approach the end of the contract cycle with American Greenz, it is the appropriate time to terminate that contract and enter into a contract with a company that is certified, MeTech Recycling.

Mr. McMillen requested the Board to allow the County Attorney to review the proposed contract with MeTech Recycling and approve the termination of the contract with American Greenz.

After a brief discussion, motion was made by Commissioner Gordon Wilder to begin the process of terminating the contract with American Greenz, and begin the contract process with MeTech Recycling, subject to review by the County Attorney. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

# Pending Business

County Water Project. Phase 1A. Mr. Ayscue reported that construction began on Monday, July 9. Unanticipated additional erosion control measures from DENR and July 4<sup>th</sup> holiday/ vacations delayed start-up of construction. According to H.G. Reynolds Construction Company, they expect to complete an average of about 500 feet of water line construction each day. They plan to start work on Warrenton Road in the vicinity of North Oliver Drive. During the past month, an additional 21 sign-ups were received. Some of the new sign-ups require adding more roads, which will lead to change orders to the construction contract. Hopefully, this will be an ongoing process. <u>Phase 1B</u>. The Kittrell Water Association and USDA Rural Development continue to work together to seek funding for Phase 1B, consistent with action taken by the Commissioners in December 2009. <u>Phases 2A & 2B.</u> Funding from USDA Rural Development has been established for both of these phases. Phase 2A will be funded with \$2.2 million in loans and \$1.62 million in grants. Phase 2B has \$3.94 million in loans and \$1.99 million in grants. USDA Rural Development has been notified that these ARRA funds must be spent on an accelerated schedule by September 30, 2012. This represents a three-year difference in time (previously September 30, 2015). An extension (waiver) request regarding the deadline has been submitted to USDA Rural Development to ensure that the project can be appropriately completed. District and state USDA RD officials are highly supportive of granting an extension, but the final decision is made at the federal level. Project design is complete and has been submitted to the appropriate regulatory agencies. Permit applications have been submitted. Highway right-of-way encroachment agreements with NC DOT have been prepared for execution. Submittal of application information to USDA Rural Development is currently being done for both phases. A potential site for a second water tank in the area covered by Phase 2A has been identified and surveyed. Due to the timing of the funding of Phases 2A & 2B, it will be important that work on these phases begin as soon as possible. A water purchase agreement with the City continues under negotiation. The approved O&M services contract will cover Phases 2A and 2B in addition to 1A. Additional sign-ups are essential in Phases 2A and 2B due to the current lack of substantial customer concentration. Current sign-up totals are 329 for Phase 2A and 334 for Phase 2B.

*Back-up 911 Center*. Mr. Ayscue reported that construction on the back-up 911 Center was completed on June 28. All of the construction-related aspects of the project were finalized prior to the June 30 deadline, thus allowing designated 911 surcharge funds to cover 100% of the cost. Separate pricing on all telecommunications equipment and secondary systems has been obtained, and installation will begin later this summer. It is anticipated that the center will be equipped, programmed, and fully operational by October 1. In response to a request from the County, the NC 911 Board has approved an additional \$144,000 in the County's annual allotment to assist with operational costs for the back-up PSAP and other E911 related costs. An application for PSAP grant funding for radio consoles in the amount of \$224,000 (no local match) has been submitted to the NC 911 Board.

#### Consent Agenda
