VANCE COUNTY EMERGENCY OPERATIONS PLAN

Updated: April 4, 2019

I. PURPOSE

This section provides for emergency medical services during natural and technological emergencies.

II. SITUATION AND ASSUMPTIONS

- A. Situation
 - 1. Vance County is served by Maria Parham Health located at 566 Ruin Creek Road in Henderson, N.C.
 - 2. One volunteer rescue squad and four EMS units are located in Vance County. A number of firefighters are trained as EMT's / First Responders. All Fire Departments operate on a First Responder level. They have primary coverage responsibility within the borders of Vance County. There are also two private ambulance companies that operate in Vance County.
 - 3. Vance County EMS generally does not provide convalescent service and interhospital transports for Vance County. The two private ambulance companies within Vance County provide this service.
 - 4. Vance County is served by Life Flight air medical services from Duke University Medical Center in Durham and by Carolina Air Care air medical services from N.C. Memorial Hospital, in Chapel Hill, N.C. East Care, Baptist
 - 5. The three nearest trauma center is Duke Medical Center in Durham, N.C., North Carolina Memorial Hospital in Chapel Hill, and Wake Medical Center in Raleigh, which are all approximately 30 to 45 minutes by road and 15 minutes by air.
 - 6. Wake Medical Center in Raleigh, Duke Regional Medical Center and Duke University Medical Center in Durham, North Carolina Memorial Hospital in Chapel Hill, Maria Parham Franklin in Louisburg and Granville Medical Center in Oxford, routinely receive patients transported by EMS units from Vance County.
 - 7. A mass casualty event has the potential to quickly overwhelm the limited existing emergency medical resources in Vance County.
 - 8. Numerous nursing homes, rest homes, and assisted living operate within the county.

- 9. At present all paid EMS units operate with Paramedics.
- 10. All EMS units rely on the Vance County Communications system for paging and dispatching.
- B. Assumptions
 - 1. A large-scale emergency will result in increased demands on volunteer first responders and medical personnel. A mass casualty event in Vance County will quickly overwhelm limited response capabilities.
 - 2. Following a disaster many of the injured will be transported to medical facilities by persons other than trained medical personnel.
 - 3. Disruption of the County's communications system would severely impede delivery of emergency medical service.
 - 4. Debris on roadways will hamper EMS unit response.
 - 5. Catastrophic disasters may affect large areas of the County and surrounding counties, and medical resources may be damaged, destroyed or unavailable.
 - 6. Following a disaster occurrence, field emergency medical facilities may have to be established; this may include a temporary morgue, a field hospital, or other State or Federal Assets.

III. CONCEPT OF OPERATIONS

- 1. EMS units will provide field medical care as needed during emergency situations and coordinate necessary medical transportation.
- 2. EMS capabilities will be expanded by incorporating volunteer fire personnel serving the respective response areas. Fire personnel will assist rescue in performing rescue of trapped victims.
- 3. During mass casualty incidents, EMS will establish patient triage, holding, treatment and transportation areas.
- 4. When necessary an EMS official will be located at an established command post to coordinate responding medical units and establish communication links with hospitals and the County Communications Center (or EOC).
- 5. Duke Life Flight, Carolina Air Care add others air ambulances could be utilized for patient evacuations. Military helicopters from Fort Bragg or the N.C. National Guard, US Coast Guard, SHP could also assist in evacuation of victims.
- 6. When additional EMS resources are needed, the Vance County Emergency Operations will request those resources through the North Carolina Division of Emergency Management.
- 7. Local industry, construction companies, and/or farming operations, may be called upon to provide specialized equipment such as refrigerated trucks, backhoes and heavy equipment for extrication of victims.
