#### COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, April 3, 2023 at 6:00 p.m. in the commissioners' conference room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those commissioners present were as follows: Chair Yolanda J. Feimster, Vice-Chair R. Dan Brummitt, Commissioners Sean A. Alston, Sr., Carolyn Faines, Thomas S. Hester, Jr., Leo Kelly, Jr., and Archie B. Taylor, Jr.

Absent: None

Also present were County Manager Jordan McMillen, Assistant County Manager Chris Dillon, Finance Director Katherine Bigelow, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Associate Pastor Mary Anderson, Shiloh Baptist Church, gave the invocation.

Public comments were heard first. Mitch Pittman, Stephen Staton and Purav Patel who were placed on administrative leave by the Sheriff two years ago after a traffic stop, stated they have not been treated fairly by the district attorney or the State Bureau of Investigation. They asked the board to request an investigation by the Federal Bureau of Investigation so the board will see that they did nothing wrong.

As advertised, the board would be sitting as the Board of Equalization and Review to hear from any taxpayers who feel their property is incorrectly listed or appraised. Porcha Brooks, Tax Administrator, was also present. There was no one present who wished to speak on this matter. The Board of E&R will remain open during this meeting and will adjourn at the conclusion of the May 1 regular meeting.

Mr. Frankie Nobles, Vance County Employee Engagement Team Chair, was first on the agenda to recognize the new employee of the month. He noted that employees are nominated by their peers, and this month's recognition goes to Argretta Johen, Vance County Human Resources Director. Her peers noted that she is extremely dependable, works tirelessly day in and day out, has a positive attitude, and does so much more than what everyone sees. Ms. Johen will receive a \$100 gift card and a designated parking space for the month. She was presented a certificate of appreciation and the board congratulated her on receiving this recognition.

Mr. Elliot Clark, Vaya Health, appeared before the board to provide an update on crisis services and the child and family improvement initiative. He noted that the local crisis center has

been closed for just over a month, but Vaya is committed to retain these services locally. The long term plan is to have a 16 bed facility and conversations are underway to acquire a building to make this happen.

Mr. Clark noted that a year ago, the board of commissioners submitted a letter to our state representatives and to the Department of Health and Human Services (DHHS) regarding concerns with DHHS's proposed statewide Medicaid Child and Families Specialty Plan (CFSP). He stated that the plan is largely the same as the one introduced last year, and would take away the authority and input from local governments and deprioritize rural health initiatives.

Motion was made by Commissioner Dan Brummitt to write a letter to our state representatives and DHHS requesting them to not proceed with the proposed statewide Medicaid Child and Families Specialty Plan (CFSP). This motion was seconded by Commissioner Carolyn Faines and unanimously approved.

As advertised, a public hearing was held to gain citizen input on a rezoning request for a parcel located at US 1 Hwy S. and W. Main Street, Kittrell (Parcel 0476 02004). Mr. Greg Edwards is the owner/applicant of the property. Planning and Development Director Keith Callahan stated that the request is to amend the zoning map and to rezone the 2.78 acre parcel from Residential Medium Density (R-20) to Highway Commercial (H-C). The proposal will place all property similarly situated in the area in the same category or in appropriate complementary categories.

As there was no one present who wished to speak on this matter, Chair Yolanda J. Feimster declared the public hearing closed.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to approve the rezoning on the basis that it is reasonable and consistent with the county's land use plan, and that the proposed zoning would be consistent with surrounding zoning and current uses.

#### Water District Board

Chair Yolanda J. Feimster called the Water District Board to order. The February 2023 monthly operations report was presented to the board for information. County Manager Jordan McMillen noted that the Phase 1B bid opening was delayed due to not receiving the required three bids. The opening has been rescheduled for Thursday, April 6.

Chair Yolanda J. Feimster adjourned the Water District Board.

#### Committee Reports and Recommendations

Technology Committee - GREAT Grant Partnership Agreement. Assistant County Manager Chris Dillon stated that the committee (Alston/absent, Taylor, and Kelly); Brummitt attending, met on Wednesday, March 15, 2023 and received an update regarding the partnership with Brightspeed through the state GREAT Grant program to expand fiber in Vance County. Brightspeed applied for \$4 million in grant funds to serve approximately 2,500 households in the county and was awarded \$1,970,990.20 from the state to serve a minimum of 664 locations. With an additional 65 residences not covered by the grant, but located along the project, the total served will be 729. He stated that the awarded grant includes a required match from the company totaling \$347,821.80 of which 50% (or \$173,911) can be provided by the local government. Brightspeed also informed the committee they are planning to serve an additional 9,941 residences within Henderson. The committee was asked to recommend a timeline for the funding agreement with Brightspeed. The committee recommended paying the county's portion as a percentage during the project construction. This allows accountability for the company and ensures county money is not spent without results to the community. He noted that Brightspeed also informed the committee of four tiers of pricing they will be offering, including a free tier for residents qualifying for the Affordable Connectivity Program (a federal program for households with income at or below 200% of the Federal Poverty Guidelines) or qualifies under other Federal programs. Recommendation: Approve the resolution related to the GREAT Grant agreement among Vance County, NC Department of Information Technology, and Brightspeed subject to final attorney review.

Motion was made by Commissioner Carolyn Faines, seconded by Commissioner Leo Kelly, Jr., vote unanimous, to approve the following resolution related to the GREAT Grant agreement among Vance County, NC Department of Information Technology, and Brightspeed subject to final attorney review:

Resolution Partnering with Brightspeed to Appropriate Funds from the American Rescue Plan Act of 2021 to Brightspeed for the Construction of Broadband Infrastructure in Unincorporated Vance County

WHEREAS, Broadband service is vital to the economic development of Vance County; and

WHEREAS, The American Rescue Plan Act ("ARPA") provided funding to Vance County, which can be used to incentivize the installation of broadband services to unserved areas of the County; and

WHEREAS, Vance County has authorized a total ARPA contribution not to exceed \$750,000 for partnership with Brightspeed in an application under the North Carolina Growing Rural Areas Through Access Through Technology Act ("GREAT Act"), and

WHEREAS, Brightspeed is a retail provider of communications services including the provision of broadband services to portions of Vance County; and

WHEREAS, Brightspeed successfully applied for a grant under GREAT Act to provide broadband services to identified unserved areas of Vance County; and

WHEREAS, Brightspeed was selected by the North Carolina Broadband Infrastructure Office to receive \$1,970,990.20 in State Fiscal Recovery Funds to expand service to 664 locations, Vance County will contribute a portion of its ARPA funds, up to \$173,911 to support the project based on the total amount awarded by the state.

**NOW THEREFORE BE IT RESOLVED** by the Vance County Board of Commissioners that:

- 1. Vance County approves the GREAT Grant agreement with the North Carolina Department of Information Technology and Brightspeed, attached hereto and incorporated by reference, to provide fiber connectivity to 664 locations within unincorporated areas of Vance County;
- 2. Appropriates \$173,911 in ARPA Revenue Replacement Funds to match the GREAT Grant local participation; and
- 3. County staff is authorized to execute the agreement and pay Brightspeed as set forth in the attached agreement.

Human Resources Committee – Commissioner Compensation. Mr. Dillon stated that the Committee (Faines, Feimster, and Taylor) met on Tuesday, March 21, 2023 to discuss changes to Commissioner compensation. Commissioners were included in the recent salary study conducted by the County last year, but Commissioner compensation still lags behind adjacent jurisdictions. The committee recommended an annual increase in compensation of \$3,000 as a market adjustment to be more in line with contiguous counties. Staff intends to include this in the recommended budget unless the board directs otherwise. Commissioners also discussed updating the County Personnel Policy Manual regarding Travel and Expense Reimbursement, with a preference of transitioning to a Per Diem policy.

Commissioner Thomas S. Hester, Jr. expressed his concerns with the salary recommendation and stated that the commissioners were included in last year's salary study and received an increase then. This would be an additional 22% increase over last year which is wrong. He asked what was being done for county employees. County Manager Jordan McMillen stated that he would like to include a 4% COLA in the proposed budget.

#### County Manager's Report

County Assembly Day – Save the Date. County Manager Jordan McMillen informed the board that the Association of County Commissioners has scheduled its County Advocacy Days on May 23 and 24, 2023. The event will include a dinner program at the Raleigh Marriott City Center on the evening of the 23<sup>rd</sup> to include an opportunity to interact with and hear from our legislators. Commissioners will then meet at the Quorum Center on the morning of the 24<sup>th</sup> before heading out to visit legislators at the legislative building. Commissioners were asked to let the Clerk to the Board know if they plan to attend.

Spring Litter Sweep Proclamation. Mr. McMillen stated that in the spring and fall of each year, the NC Department of Transportation (NC DOT) sponsors cleanup campaigns to beautify the roadsides of the state. This year, DOT is sponsoring its Spring Litter Sweep Campaign on April 15 - 29, 2023. Recommendation: Approve the proclamation designating April 15 – 29, 2023 as Spring Litter Sweep in Vance County.

Motion was made by Commissioner Carolyn Faines, seconded by Commissioner Dan Brummitt, vote unanimous, to approve the following resolution designating April 15 – 29, 2023 as Spring Litter Sweep in Vance County:

# PROCLAMATION by the Vance County Board of Commissioners in Recognition of the 2023 Spring Litter Sweep

- WHEREAS, in conjunction with the North Carolina Department of Transportation, Vance County supports and encourages participation in the Spring 2023 roadside cleanup effort to ensure clean and beautiful roads throughout the County; and
- WHEREAS, the Spring 2023 Litter Sweep roadside cleanup campaign will occur April 15 29. - **WHEREAS**, as a Master Trooper, he was a Field Training Officer, a Traffic Crash Instructor and a Taser Instructor at the Highway Patrol Training Center; and
- WHEREAS, his long career in law enforcement saw him work with the Vance County Sheriff's Office, the Henderson Police Department, and the Wilson Police Department before serving with the North Carolina State Highway Patrol; and
- WHEREAS, Master Trooper Montgomery was highly respected and admired throughout the local and regional law enforcement community as an exemplary officer who was dedicated to executing his public duties and responsibilities in a manner which brought pride and dignity to his profession.
- **NOW, THEREFORE BE IT RESOLVED THAT** the Vance County Board of Commissioners does hereby request the North Carolina Department of Transportation name the Satterwhite Bridge over I-85 for Master Trooper James "Brent" Montgomery.

Award of Service Weapon and Badge. Mr. McMillen informed the board that Sheriff Curtis Brame has requested the award of the service weapon and badge to Lt. Nathaniel R. Shearin following his retirement January 1, 2023. He has served Vance County for 30 years. NCGS 20-187.2 states that former LEO's who retire from the Office of the Sheriff shall receive their badge at no cost to them, on written request. As per county policy, he is also eligible to receive his service weapon.

Motion was made by Commissioner Carolyn Faines to award the service weapon and badge to retired Lt. Nathaniel R. Shearin, according to County policy. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Orphan Roads. Mr. McMillen provided a memo to the board regarding orphan roads in response to public comments made at the March board meeting. He stated that when a developer fails to turn newly constructed private roads over the NCDOT they become orphan roads as there is no legal entity responsible for the road, and maintenance falls on the owners of the private neighborhoods. This is a statewide issue and in Vance County is prevalent with subdivisions

developed prior to the County creating subdivision regulations in 1999. The Association of County Commissioners continues its efforts to lobby for state and federal funding options to address orphan roads. The memo outlined the legally permissible method for these roads to be brought up to NCDOT standards to allow NCDOT the opportunity for taking maintenance of the roads.

Goals for FY 2023-24. Mr. McMillen presented the following goals as developed and prioritized during the board's planning retreat and recommended approval of the goals as presented.

- 1. Explore opportunities for partnerships (VGCC and others) that seek to enhance small business development.
- 2. Successful implementation of Economic Development Strategic Plan.
- 3. Begin planning and identifying opportunities for distributing and utilizing opioid settlement funds and support educational programs that seek to reduce drug dependency.
- 4. Implement a community paramedicine program that seeks to improve community health, reduce frequent fliers, and assist in lowering EMS call volume.
- 5. Begin construction of Phase 1B of the county water system and offer public information/signup meetings with a goal of increasing signups 20% above the current level.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Leo Kelly, Jr., vote unanimous, to approve the FY 2023-24 Goals as presented.

Commissioner Work Session Schedule. Mr. McMillen noted that the board indicated a desire for a regular work session each month. A draft schedule was provided for the board to consider which does not include the months of June, July and December. He noted that staff would prefer a daytime or late afternoon work session time.

The board discussed the time and decided on 4:00 p.m.

Motion was made by Commissioner Carolyn Faines to approve the revised 2023 Board of Commissioners Meeting Schedule to include adding scheduled work session meetings to be held the 3<sup>rd</sup> Monday at 4:00 p.m. This motion was seconded by Commissioner Leo Kelly, Jr. and unanimously approved.

Drewry Solid Waste Site Paving. Mr. McMillen noted that Vance and Warren Counties share the operational and maintenance cost of the Drewry Solid Waste Site. He stated that recent discussions with Warren County indicates a desire to proceed with paving the site and they are in agreement for reimbursing Vance County 50% of the costs. Staff has obtained quotes and the low bid totals \$42,395 from Reynolds Hauling. Staff would like to proceed with paving the site in a similar manner to what was recently done at the Kittrell site. He stated that the properties committee previously stated that pavement was a better long term investment saving future maintenance costs while improving the citizen experience. Funds are available in the capital fund for completing the project.

Motion was made by Commissioner Carolyn Faines, seconded by Commissioner Thomas S. Hester, Jr., vote unanimous, to award the contract to Reynolds Hauling totaling \$42,395 from the capital fund to pave the Drewry Solid Waste Convenience Site, with Warren County reimbursing Vance County 50% of the costs.

### Finance Director's Report

KARTS Funding Request. Finance Director Katherine Bigelow stated that KARTS is a transportation authority created by joint resolution of the Boards of Commissioners of Granville, Vance, Warren, and Franklin Counties. Their board includes one commissioner as well as one human service organization representative from each county. Their total annual expenditures are approximately \$3.75 million of which 80% is funded by the federal government with a portion funded by the state, and 10-15% funded by the local counties (10% capital and 15% administration). She noted that KARTS has been without a finance director for several months and has requested emergency funding from each of the counties to get through the remainder of the fiscal year. According to the interim director, they are in need of \$75,000 to close out the fiscal year plus the \$19,127 (requested 56,588 and we provided \$37,461) that the county did not provide in the current year budget which serves as a match for their other federal and state funding. The KARTS board has directed the interim director to seek out contracted assistance for financial accounting and there is the possibly the counties may need to cover the cost of this contracted assistance in the future. County staff has reached out to the Kerr-Tar COG to see if they can provide any assistance to KARTS. Additionally staff is aware that NCDOT has reached out and offered guidance and assistance with the reimbursement process for receiving their state and federal funds.

After a lengthy discussion, it was noted that it is anticipated that a recommendation will be brought before the board at its May meeting.

#### County Attorney's Report

REO Property – New Offer. County Attorney Jonathan Care stated that a new offer has been received for real property located at 1010 Standish Street – Parcel 0091 07007A. He stated that the board needs to vote on whether or not to proceed with the sale by advertising for upset bids and recommended approval of the resolution to begin the upset bid process for the property.

Motion was made by Commissioner Dan Brummitt to approve the upset bid process for real property located at 1010 Standish Street – Parcel 0091 07007A. This motion was seconded by Commissioner Thomas S. Hester, Jr. and unanimously approved.

## RESOLUTION AUTHORIZING UPSET BID PROCESS FOR SALE OF REAL PROPERTY 1010 Standish Street, Henderson, NC 27536

- WHEREAS, Vance County owns certain real property with an address of 1010 Standish Street, Henderson, North Carolina, and more particularly described by the Vance County Tax Department as Parcel Number 0091 07007A; and
- WHEREAS, North Carolina General Statute §160A-269 permits the county to sell real property by upset bid, after receipt of an offer for the property; and
- WHEREAS, the County has received an offer to purchase the real property described herein above in the amount of \$900.00 subject to the terms and conditions as included in the submitted offer to purchase bid, submitted by WaKisha Turrentine; and
- WHEREAS, WaKisha Turrentine has paid the required deposit in the amount of \$750.00 with the offer.

# THEREFORE, THE VANCE COUNTY BOARD OF COMMISSIONERS RESOLVES THAT:

- 1. The Board of County Commissioners declares the real property described above surplus and authorizes its sale through the upset bid procedure of North Carolina General Statute §160A-269.
- 2. A notice of the proposed sale shall be published which shall describe the property and the amount of the offer and shall require any upset offer be subject to the same terms and conditions as contained therein except for the purchase price.
- 3. Any person may submit an upset bid to the Clerk to the Board of County Commissioners within 10 days after the notice of sale is published. Once a qualifying higher bid has been received, that bid will become the new offer.
- 4. If a qualifying bid is received, a new notice of upset bid shall be published and shall continue to do so until a 10-day period has passed without any qualifying upset bid having been received. At that time, the amount of the final high bid shall be reported to the Board of County Commissioners.

- 5. A qualifying higher bid is one that raises the existing offer by the greater of \$750 or ten percent (10%) of the first \$1,000.00 of that offer and five percent (5%) of the remainder of the offer and is subject to the same terms and conditions of the previous bid.
- 6. A qualifying higher bid must also be accompanied by a deposit in the amount of the greater of \$750 or five percent (5%) of the bid, which may be made by cash, cashier's check or certified funds. The County will return the deposit of any bid not accepted and will return the bid of an offer subject to upset if a qualifying higher bid is received.
- 7. The terms of the final sale are that the Board of County Commissioners must approve the final high offer before the sale is closed and the buyer must pay with certified funds or wire transfer the bid amount and any other amounts as required pursuant to the terms and conditions of the bid at the time of closing, which shall be no later than 30 days following the approval by this Board of the final bid. The real property is sold in its current condition, as is, and the County gives no warranty with respect to the usability of the real property or title. Title will be delivered at a closing by a **Non Warranty Deed**, subject to exceptions for ad valorem taxes, assessments, zoning regulations, restrictive covenants, street easements, rights of others in possession and any other encumbrances of record. Buyer shall pay for preparation and recording of the Deed and revenue stamps.
- 8. The County reserves the right to withdraw the property from sale at any time before the final high bid is accepted **and the right to reject all bids at any time**.
- 9. If no qualifying upset bid is received, the Board of County Commissioners will accept or reject the bid submitted within 60 days after the close of the 10-day upset period.

Conflict of Interest Waiver – KARTS. Attorney Care informed the board that KARTS has requested him to sign its annual audit letter for its auditors. In light of recent events with KARTS, he declined signing the letter. Since then, KARTS has requested that he ask the board of commissioners to waive the conflict of interest. KARTS would also waive the conflict of interest. KARTS informed him that the signed letter is the only item keeping them from completing their 2021 audit.

After brief discussion, motion was made by Commissioner Thomas S. Hester, Jr. to waive the conflict of interest for the KARTS 2021 audit letter, contingent upon KARTS taking similar action. This motion was seconded by Commissioner Sean A. Alston, Sr. and unanimously approved.

Vance County vs. Davis Hecker. Attorney Care provided an update on this zoning violation case and stated that Mr. Hecker was served by certified mail and April 12 is the deadline for him

to file an answer. If an answer is not received by that time, the county will move forward with a default entry and ask the court for a default judgment.

*EMS Land Update*. Attorney Care stated that the sellers have agreed to a 90-day extension and he is continuing to work with the property owner of the Dollar General. He stated that it appears that we will get a release of the subject restrictive covenants.
