
Metered Aging Report for VANCE COUNTY

Committee Reports and Recommendations

Vance County Committee Reports and Recommendations November 6, 2023

Public Safety Committee

EMS Land Acquisition. The Committee (Alston/via phone, Brummitt, and Faines); Taylor attending, met on Monday, October 16, 2023 and reviewed a matrix prepared by staff to determine what the committee/commissioners desire in a piece of property. The committee agreed that they would like the land to be in Williamsboro area, and directed staff to put available lands into Matrix and continue working on moving towards a purchase. *Recommendation: Direct staff to continue seeking property for purchase for a Northern Vance County EMS substation.*

Vehicle Use Policy. The commissioners asked staff to review the Vehicle Use Policy and the committee recommends the following amendments to the policy:

- 1. Emergency Management: only "on-call" personnel is allowed to take vehicle home, except the director.
- 2. Animal Control: only "on-call" personnel is allowed to take vehicle home, except the animal services manager.
- 3. Social Services: no take home vehicles.
- 4. Tax Office: no take home vehicles.
- 5. Planning: no take home vehicles.
- 6. EMS: no take home vehicles except EMS Director.
- 7. Fire: no take home vehicles expect the Fire Chief.

Other changes:

- 1. GPS is to be left on at all times.
- 2. All county vehicles (subject to this policy) will be marked with Vance County logo.
- 3. All county vehicles (subject to this policy) will have legal tint regulations throughout the entire car, unless for security/safety reasons.

Unchanged: Overnight assignment will not typically be granted to any employee that lives outside of five (5) mile radius from the nearest county limit. Certain circumstances can be approved or recommended at the discretion of the County Manager. *Recommendation: Direct staff to begin making the above changes to the "Use of County Vehicles" policy inside the Vance County Policy and Procedure Manual.*

Rural Fire Department's Fund Balance Disposal Request and Fire Tax Rate. The committee was presented with a letter from the Vance County Fire and Rescue Association requesting the available fund balance in the Fire Tax fund to be paid out to all the departments. This was a unanimously signed letter by all the fire chiefs. The request also was to leave the tax rate the same on the newly assessed values following the tax revaluation. This will offset the rising costs in the rural departments providing services to Vance County. *Recommendation: Leave the fund balance in place and not disperse the monies until the results from the Vance County Fire Study is complete, as well as wait until the tax revaluation is complete to further discuss the tax rate.*

Staff sent email to all chiefs regarding the state appropriation funding for rural fire departments, if they choose to need funding.

Uniforms. The committee stated that if a department is provided uniforms, employees are expected to wear those uniforms on a regular basis.

1.0 PURPOSE

This policy is established to regulate the operation of County vehicles assigned to employees in the performance of their duties and where applicable, the use of personally owned vehicles when used on county business.

2.0 USE OF COUNTY-OWNED VEHICLES Permitted Uses

- a. Only County employees authorized by departments may operate County Vehicles or equipment.
- b. County-owned vehicles are to be used for official business only with reasonable consideration for use for meals, while in the course of performing business on behalf of the County. For individuals assigned vehicles for overnight use, stopping between work and home to perform brief minor personal business may be acceptable, <u>BUT</u> any such use should be the <u>EXCEPTION</u> rather than the rule, and only if the stop is directly in route from work to the employee's residence.
- c. All passengers accompanying County employees in County vehicles must have a business interest in the travel. Due to insurance limitations and regulations, no other passengers are permitted unless authorized by the County Manager. Any exceptions would require the employee to complete and have placed in their personnel file a waiver of responsibility form.

Driver Requirements

- a. The driver of any County-owned vehicle must have a valid Driver's license. County employees who drive vehicles weighing 26,001 pounds or more or carrying 16 or more passengers must have a valid Commercial Class B license with a passenger endorsement. County employees who drive a combination of vehicles weighing 26,001 pounds or more provided the weight rating of the vehicle or vehicles being towed is more than 10,000 pounds must have a valid Commercial Class A license with a passenger endorsement.
- b. All employees who operate county vehicles or their personal vehicle for County business shall have their driving record checked; new employees shall be checked upon hire and all other employee drivers shall be checked every three years. These record checks will be conducted by the county HR Director. A point's based review will be used to determine proper recommended action.

- c. Employees will be responsible for any vehicle or equipment assigned to them and shall ensure <u>all</u> policy guidelines are followed.
- d. Employees driving County vehicles are required to obey all traffic laws.
- e. Vehicles are to be driven in a manner that creates a favorable impression with the public. Drivers will exercise special precaution when:
 - Children are playing on the roadway, alley or near the curb
 - Passing schools, playgrounds or school buses
 - Approaching pedestrians or persons on bicycles.
 - Adverse weather or road conditions are encountered.
- f. No vehicle will be operated if any controlling mechanism (such as steering, brakes, headlights, horn or windshield wipers) is not in proper working condition. Do not operate a vehicle that is not in proper mechanical condition; report such conditions to your supervisor and/or designated departmental vehicle coordinator.
- g. Drivers and all passengers must wear seat belts at all times. Exemption: Employees with medical conditions that would be worsened by seatbelt use. Employee must have a Physician's note on file with his/her department head.
- h. Employees who are cited for a traffic/moving violation (such as excessive speeding, DWI, etc.) while operating a County vehicle must notify their Supervisor or Department Head immediately. The County will not pay traffic tickets or parking fines, including those received while using personal vehicles for County business. Employees found guilty of a moving violation may be subject to disciplinary action by their supervisor.
- i. Employees with a license status change that prevents them from legally operating a vehicle shall notify their Supervisor or Department Head immediately.
- j. The use of tobacco, in any form, is prohibited in County owned vehicles.
- k. Alcoholic beverages and/or drugs are not permitted in County vehicles at any time; however, law enforcement personnel may transport lawfully confiscated alcoholic beverages and/or drugs.
- 1. The use of a mobile telephone for voice communications while operating a County vehicle or while operating a personal vehicle on official County business is discouraged except in emergency situations. Employees should park their vehicle in a safe manner and location when it becomes necessary to use a mobile telephone for voice communications inside the vehicle.

It is unlawful under N.C.G.S 20-137.4A for "any person to operate a vehicle on a public street or highway or public vehicular area while using a mobile telephone to: (1) Manually enter multiple letters or text in the device as a means of communicating with another person; or (2) Read any electronic mail or text message transmitted to the

device or stored within the device, provided that this prohibition shall not apply to any name or number stored in the device nor to any caller identification information." This law does not apply to "(1) The operator of a vehicle that is lawfully parked or stopped; (2) Any of the following while in the performance of their official duties: a law enforcement officer; a member of a fire department; or the operator of a public or private ambulance; (3) The use of factory-installed or aftermarket global positioning systems (GPS) or wireless communications devices used to transmit or receive data as part of a digital dispatch system; and (4) The use of voice operated technology.

m. All drivers shall take a Defensive Driving Course (DDC). All existing drivers should be scheduled to take DDC within six months of the implementation of this policy. New employee drivers should take DDC within ninety (90) days of being assigned to drive County vehicles or use personal vehicles on County business. This course shall be offered through the Human Resources office quarterly. Emergency Vehicle Driver (EVD) Training to include in-vehicle training is required for departments responding in emergency vehicles and may be substituted in place of the Defensive Driving Course.

Vehicle Assignment

- c. County vehicles are normally assigned to an individual at the start of their assigned work period, and are the employee's responsibility until the completion of the period.
- d. A County vehicle may be assigned to an individual employee who regularly requires the use of the vehicle both on and off duty. Such an assignment may be of a permanent nature or for a specified time period, such as a week of on-call duty. To the extent possible, specific employee/vehicle assignments should be made rather than the use of "pool" vehicles. Doing so should promote better accountability for vehicle condition and operation.
- e. Overnight assignment will not typically be granted to any employee that lives outside of a five-mile (5) radius from the nearest County limit boundary of the County, unless specifically approved by the County Manager.
- f. During vacation periods or leaves of absence, an employee who is assigned a vehicle on a non-permanent basis will turn the vehicle in to their department.

3.0 ACCIDENTS

If the vehicle is involved in an accident, the driver's first duty is to stop the vehicle. Regardless of the situation, the following procedures must be followed in the event of an accident:

- a. Immediately notify the local law enforcement agency to obtain their accident investigation and report, as well as report any emergency needs.
- b. Notify supervisor, department head, and county Finance Director within one hour. If, as a result of the accident, you are rendered physically unable to make this notification within one hour, you must make the notification within 24 hours of the accident. Notification must include a thorough admission of any and all property damage, as well as any personal injury to the driver and/or any passenger, including possible Worker's Compensation claims.

- c. Complete an Incident Investigation form within 24 hours. This report, along with the law enforcement agency's report, should be turned in to the finance office.
- d. Notify your supervisor of any possible injuries to yourself, including possible workers' compensation claims. If medical treatment is needed, complete the Employees Initial Report of Injury form (can be obtained from your supervisor).
- e. The department head of the employee involved in an accident is responsible for obtaining damage estimate(s) on the County vehicle within 3 business days and must notify the County Manager within 8 hours of the accident.
- f. Failure to promptly report accidents and provide the necessary information may result in a loss of County driving privileges, suspension, demotion or dismissal.

Employees involved in an accident will be required to submit to drug or alcohol screening if the Human Resources Director, in consultation with the employee's Department Manager, determines there is reason to believe the employee's acts or omissions may have contributed to the accident. Some of the objective criteria that will trigger a post-accident test include: fatalities; injuries that require anyone to be removed from the scene for medical care; damage to any vehicle to the extent that it must be towed. The post-accident test should be conducted as soon as possible and not to exceed six hours following the accident.

4.0 MAINTENANCE AND CARE OF COUNTY VEHICLES

Vehicles must be kept clean at all times. It is the assigned driver's responsibility to maintain the vehicle in a clean condition.

Maintenance

- a. A vehicle number will be assigned by the department head and shall be affixed and visible from the rear of the vehicle. County vehicles shall include insignia or lettering on the side or door identifying them with Vance County. Exceptions apply for vehicles used for special undercover or confidential investigative purposes.
- b. The department head or his/her designee is responsible for making an appointment and ensuring periodic maintenance of the vehicle at the vehicle maintenance facility designated by the county. Schedule the appointment when the vehicle mileage is within 500 miles of the next service. It will be the driver's responsibility to have the vehicle at the contracted service location at the designated time and to pick up the vehicle when finished.
- c. Emergency repairs during normal working hours will be completed by the vehicle maintenance facility designated by the county, with EMS and Sheriff's departments given top priority.
- d. In the event of a mechanical failure, employees will call the department head or his/her designee to report the need for service and possibly a wrecker.

- e. Special equipment (fire extinguisher, first aid kits, gasoline cards, etc.) must stay with the vehicle at all times. Important information (warranty booklet, tag registration cards, state inspection certificate, owner's manuals, and driver accident information) should also remain with the vehicle at all times. Drivers are responsible for the security of these items.
- f. The driver and/or department head is responsible for ensuring that mechanical fluid levels are maintained, including gasoline, engine oil, transmission fluid, radiator fluid, washer fluid, etc.

Vehicle Replacement

All county vehicles will be replaced as mechanical and safety conditions dictate.

5.0 SAFE DRIVER PROCEDURES

All employees operating a county vehicle or where applicable, a personal vehicle for county business must adhere to the following practices and procedures.

a. Accident Reporting

If you are involved in an accident, follow these procedures:

- Stop. Failure to do so is a criminal offense, and may also result in County disciplinary action.
- Stay calm.
- Do not admit fault or blame other persons.
- Obtain names of any witnesses.
- Obtain an incident report from appropriate law enforcement agency i.e. police.
- Obtain names, addresses and telephone numbers of all other persons involved (including drivers, passengers, pedestrians and/or other persons possibly injured, and owners of property possibly damaged.)
- Exchange automobile insurance information with other persons involved (including vehicle owners and drivers). This information should include the name of the insurance company and the policy number for each driver and/or vehicle involved.

If someone is hurt or there is danger of fire, explosion or other further damage, call 9-1-1. Assist injured to the extent possible.

If you are injured or suspect an injury, notify your supervisor.

Within 24 hours following the accident, fill out an Incident Investigation Form (including diagram of the accident) and turn it in to your supervisor.

b. Drugs

Drivers will not drive after having consumed alcohol and/or drugs, including legal drugs that may impair their ability to operate a motor vehicle.

c. Vehicle Inspection

Drivers and/or department head or his/her designee will inspect vehicles periodically. Any items checked needing attention; damage or other unusual conditions will be reported to the

department head. It is the responsibility of each driver to ensure that their vehicle is operating properly at all times.

Any employee who is instructed to drive a vehicle they feel is unsafe has the right to contact the department head or his/her designee for inspection and a decision as to whether the vehicle should be driven.

d. Cleanliness

Vehicles are to be maintained in a clean condition, especially the windshield. They are to be kept free of interior debris or trash, especially in those areas that could impair operation.

POINTS-BASED REVIEW OF MOTOR VEHICLE RECORDS

Periodic review (every three years) of the drivers' Motor Vehicle Record (MVR) is helpful in monitoring overall driver performance and in predicting future problems. To help motivate these persons to drive safely and obey traffic laws, the County shall implement an employee policy dictating the need for remedial training or stronger disciplinary measures. This policy shall be based on the accumulation of points incurred through driving violations reported on the MVR.

Point's accumulation for violations or accidents as they appear on the motor vehicle record should use the conviction date as the date of reference. As defined below, points for major violations should be assessed for four years from the conviction date. Minor violations should be assessed for three years from the conviction date. Should a violation occur in conjunction with an accident and the driver receives points for both, only the higher total should apply. Points should be assigned for violations occurring both on and off the job.

1. COMMON VIOLATIONS AND POSSIBLE POINTS

Major Violations (8 points)

- Driving while intoxicated
- Racing
- Fleeing from the scene of an accident
- Driving under license suspension or revocation
- Fleeing from a law enforcement officer
- Passing a stopped school bus

Minor Violations (4 points)

- 20 or more MPH above the speed limit
- Improper driving/Reckless driving
- Failure to drive on the right side of the road
- Passing on the yellow line
- Running a red light

Minor Violations (2 points)

- 19 or less MPH above the speed limit
- Failure to yield right of way
- Failure to obey traffic signals
- Failure to provide proper signal
- Following too close
- Seatbelt Violations

Note: This list is not all-inclusive.

Consultation between the County and driver should occur for these actions.

POINTS-BASED EMPLOYEE DISCIPLINARY POLICY FOR ACCIDENTS

A County Vehicle Accident Review Board shall investigate and review all motor vehicle accidents involving county vehicles.

1. Upon review of the accident, the County Vehicle Accident Review Board will gather and analyze the factor(s) contributing to the accident to determine preventability on the part of the County driver. Each accident will be given one of the following designations, and the employee may be assigned points accordingly.

•	Non-preventable	No points
•	Questionable preventability	2 points
•	Preventable	4 points
•	Definitely preventable/serious	8 points

An additional 6 points will be assigned to any driver who fails to promptly report an accident to his or her supervisor and/or a law enforcement agency. Any employee involved in a moving vehicle accident not wearing a seat belt will receive an additional 4 points.

2. A uniform disciplinary procedure will result from the accumulation of points, based on a 24 month accumulation period.

Finance Director's Report

Vance County Finance Director's Report to the Board November 6, 2023

A. Education Lottery Fund Applications. A joint application filed by the County Commissioners and the Board of Education must be submitted to the State in order to draw down available North Carolina Education Lottery funds from the Public School Building Capital Fund. The County has budgeted to use lottery funds to pay the debt service for the 2010 QSCB and 2013 QZAB projects. The Board of Education approved the applications at its October 9, 2023 meeting for \$384,775.96. *Recommendation: Approve the applications to draw down lottery funds to be used for debt service payments on existing school facilities debt.*

B. FVW Head Start Lease Agreement. After meeting all statutory requirements, we are ready to proceed with approving the lease agreement for the kitchen at the Eaton Johnson Complex to the FVW Head Start. We are excited and thankful for all the work they do in our community. *Recommendation: Approve the lease amendment for FVW Head Start Program.*

C. Industrial Park – Road and Sewer Project Bid Opening. See attached minutes and budget from bid opening, noted by grant administrator Frank Frazier with Kerr Tar. Triangle Grading was the lowest bidder at \$1,149,379.60. The total project budget is \$1,314,880.00. The current shortfall is \$138,390. To move forward with the EDA Grant, shortfall funding needs to be secured even if it isn't utilized. *Recommendation:* Approve budget amendment #9 to appropriate \$138,390 as County Contribution to fulfill funding.

D. Clean-up of Former Vance Manor Site. Chair Feimster instructed staff to get quotes to clean up county owned land at the old Vance Manor site on Cherry St. Staff received quotes and would like to proceed with Woodlief's Lawn care for \$2,900 which is for "brush/debris cutting and removal" of 5 acres. To maintain it each year will be much cheaper. There are funds in contingency to cover this expense. No appropriation needed. *Recommendation: Authorize staff to work with Wooflief's lawn care as presented.*

E. Resolution - Operation Green Light. Operation Green Light is an initiative endorsed by the NC Association of County Commissioners (NCACC) and the National Association of Counties (NACo) and the National Association of County Veteran Service Officers (NACVSO) that shows support and honor for military veterans. During Operation Green Light, residents and businesses are asked to shine a green light or light their buildings green from November 6 to November 12 as a way of letting veterans know they are seen, appreciated, and supported. The resolution supports this effort, which will include lighting the exterior lights at the Henry Dennis Building green. *Recommendation: Approve resolution supporting operation green light for veterans.*

F. Eaton Johnson Chiller Pump Replacement. There are 8 pumps and an air handler that needs to be replaced at the Eaton Johnson (Main Building), they are over 35 years old. The bid opening was Thursday 10/26. 4 bids came in, the lowest bid was Gupton Services for \$221,958. When only budgeted \$195,000 for this project including engineering. At the time that was sufficient. *Recommendation: Approve budget amendment #7 to appropriate necessary funds, and to award the bid to Gupton Services.*

Authorizing the Lease of Real Property Pursuant to NCGS §160A-272

- WHEREAS, pursuant to NCGS § 153A-176 and 160A-272, Vance County may, upon such terms and conditions as it deems wise, with or without consideration, lease any interest in real property; and
- **WHEREAS**, Vance County did previously, lease to Franklin-Vance-Warren Opportunity, Inc. a portion of the building located at 500 N. Beckford Drive, Henderson, North Carolina; and
- **WHEREAS**, Franklin-Vance-Warren Opportunity, Inc. has requested to lease additional space that is now available at the same location; to wit; 3,632 square feet commercial kitchen area and non-exclusive rights to the use of the loading dock located within the same Eaton Johnson Complex; and
- **WHEREAS**, Vance County had previously determined this section of the complex would not be needed during the term of the lease, and does continue to affirm such determination.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners for the County of Vance as follows:

- 1. The real property known as the 3,632 square feet commercial kitchen and non-exclusive use of the loading dock located within the Eaton Johnson Complex located at 500 N. Beckford Drive, Henderson, North Carolina is not needed by the County for the term of the proposed lease attached hereto and incorporated by reference.
- 2. The first lease amendment (attached hereto and incorporated by reference) to include this additional real estate with an initial term through June 30, 2027, with one additional lease term extensions for five years (July 1, 2027-June 30, 2032), and a rental rate of \$10 per square foot per year is hereby authorized and approved.
- 3. A notice of the proposed lease as required by NCGS 160A-272 was published on October 3, 2023.
- 4. The Chair or the Interim Vance County Manager are hereby authorized to execute any and all documents related to affecting the above authorized first lease amendment.

FIRST LEASE AMENDMENT



Fall Vegetable Garden

The fall season is upon us and with the temperatures keeping at a low, it's the perfect time to prepare your vegetable garden for winter. Preparing your garden is just as important as the planning, preparation and planting that takes place each year in the spring.

Wayne Rowland shared information on how to extend the vegetable growing season using frost protective row covers and using High Tunnels to grow vegetables during the non-traditional growing season with local farmers at the Vance County Regional Farmers Market on Monday, September 25th. Using a high tunnel will protect your plants from bad weather and allow our local farmers to extend their growing season while improving the quality of the plant and soil.

Evaluations from the participants stated that they had increased their knowledge about the Extension of their fall and winter vegetable garden and High Tunnel vegetable production. They stated they would adopt Cooperative Extension recommendations this year.





Fall Turf Tip by paul mckenzie

Fall is a key season for tall fescue lawn maintenance. This turf will benefit from a fertilizer application applied in middle to late November. A slow release fertilizer designed for turf is recommended, and it is usually best to avoid products that are combined with a weed killer or insecticide unless a specific problem has been identified. Keep in mind that the preferred time for sowing seed has already passed. Any overseeding or reseeding is best scheduled for early September.



Pesticide Certification

Each year during September, Cooperative Extension works to insure that farmers and other professional pesticide applicators have the continuing education they need to maintain appropriate certification. Cooperative Extension offers a variety of these classes which provide applicators with the information they need to protect the environment, work safely and stay healthy. Three such classes were offered in the month of September to help farmers meet a key deadline.

North Carolina's agricultural industry, including food, fiber and forestry, contributes \$91.9 billion to the state's economy, accounts for more than 17 percent of the state's income, and employs 17 percent of the workforce.

North Carolina is one of the most diversified agriculture states in the nation. The state's 46,418 farmers grow over 80 different commodities, utilizing 8.4 million of the state's 31 million acres to furnish consumers a dependable and affordable supply of food and fiber. The state ranks eighth nationally in Total Market Value of Agricultural Products Sold. Net income per farm in the state is over \$86,645.

This Local Food and Farms infographic is designed for economic developers, planners, local food advocates, and import of a second seco agricultural businesses as key components of vibrant and resilient, local and rural economies. Each region in North Carolina presents a unique set of opportunities for sustainable economic growth and entrepreneurship

Consider one example: When school systems purchase food from local farmers, students benefit from access to healthy fresh produce, farmers benefit from sales into local schools, and the community benefits because these local sales are spent at other local businesses. This type of local business opportunity keeps farms in production, maintaining North Carolina's agricultural asset base both in terms of land and farming know-how. And it keeps dollars spent on food circulating among other local businesses.



The Incredible Years Program

The Incredible Years program is in our fifth week of fifteen sessions and we are having loads of fun with our parents. Currently, we are discussing the wondrous effects child-directed play has on children. We role-play scenarios and answer very specific questions during our time together.

One of the discussion points centered around what to do when your child has trouble disengaging from play.

The general rule is to establish expectations and routines that they can rely on. For example; before you start playing, inform them that playtime has a specific time limit. If you want to use the timer on your phone or a regular kitchen timer, you want to let them know that when your timer goes off it will be time to start cleaning up so they can move to the next thing.

Once the timer goes off they will recognize that it's time to stop and clean up (they will ignore this the first time). 



10/02/23- The VA says it's been listening to feedback on the Post-9/11 GI Bill Transfer of Entitlement (TOE) application experience, finding that many people felt it was too lengthy and time consuming.

As a result of use ability testing and feedback, the VA has launched the Digital GI Bill (DGIB) initiative. The VA says it wants the "GI Bill to work for you."

As of March 2023, the application process, according to the VA, has been improved for families. The application is streamlined to use transferred Post-9/11 GI Bill benefits. It's available now at VA.gov.

To apply, a veteran and their family member will need to check their eligibility. The Department of Defense determines if your benefits can be transferred to a family member.

Dependents may be able to access money to cover expenses including, tuition, housing, books and supplies fees for national standardized tests, and fees for licensing and certifications.

You can request a transfer up to a total of 36 months of your remaining education benefits to your dependents.

A spouse can use benefits right away whether the service member is on active-duty or has separated from service. If the separation from active duty was before January 1. 2013, a spouse can use the benefits for up to 15 years after separation from active duty.

If a service member separated from active duty on or after January 1, 2013, then their spouse can use the benefits at any time, with no time limit on them.



For children, benefits can start to be used after the service member has finished at least 10 years of service. The benefits can be used while on active-duty or after separation from service.

A child has to meet certain requirements. First, they can't use the benefit until they've gotten a high school diploma or turned 18 years old, and second, they have to use the benefits before turning 26 years old.
