COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, November 6, 2023 at 6:00 p.m. in the commissioners' conference room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those commissioners present were as follows: Chair Yolanda J. Feimster, Vice-Chair R. Dan Brummitt, Commissioners Sean A. Alston, Sr., Carolyn Faines, Thomas S. Hester, Jr., Leo Kelly, Jr., and Archie B. Taylor, Jr. Absent: None.

Also present were County Manager C. Renee Perry, Finance Director Katherine Bigelow, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Rev. Joseph Ratliff, Shiloh Baptist Church, gave the invocation.

Chair Feimster introduced Renee Perry as the new county manager. Ms. Perry stated that she is happy to be with Vance County and is looking forward to working with everyone.

Public comments were heard next. Mr. Jonathon Edwards stated that he owns a business on US 1 Hwy and would like to place an LED billboard on his property. He noted that he has met with the county's planning department, and this would require a change to the existing zoning ordinance. Chair Feimster referred this request to the county manager.

Ms. Megan Cottrell, Vance County Animal Services Lead Officer, expressed her concerns with the public safety committee's proposed changes to the county's vehicle use policy. The proposed changes would limit take home vehicles to only the officer on call and the chief. She stated that when calls are emergencies, off-duty officers have responded because they were closer to the call. If they did not have their vehicle with them, they would lose valuable time driving to the shelter first to retrieve their county vehicle. Chair Feimster stated that the committee has not made a final decision on this matter and asked Ms. Cottrell to relay her concerns to the county manager.

Ms. Argretta Johen, Vance County Employee Engagement Team Member, appeared before the board to recognize the new employee of the month. She noted that employees are nominated by their peers, and this month's recognition goes to Ann Hudson with Vance County Human Resources. Her peers noted that she is extremely dependable, has an exemplary work ethic, and always remains positive. Ms. Hudson will receive a \$100 gift card and a designated parking space for the month. She was presented a certificate of appreciation and the board congratulated her on receiving this recognition.

Tax Administrator Porcha Brooks was next on the agenda and presented the following untimely exemption applications for approval. She stated that if the applications had been submitted by the deadline, she would have approved them at the staff level.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Carolyn

Faines, vote unanimous, to approve the exemptions as requested.

Mr. Ryan Vincent, Vincent Valuations, appeared before the board for the adoption of the 2024 Schedule of Values. He noted that the board had received a copy of the Schedule of Values on September 22, 2023 and a public hearing was held on October 2, 2023. Once the Schedule is adopted, a notice will be published in the newspaper for four successive weeks noting the adoption. Taxpayers who feels the Schedule is invalid may appeal to the NC Property Tax Commission within 30 days of the first published date.

Motion was made by Commissioner Dan Brummitt to adopt the 2024 Schedule of Values, Standards and Rules. This motion was seconded by Commissioner Carolyn Faines and unanimously approved.

Mr. Elliot Clark, Vaya Health, appeared before the board and provided an update on the diversion center program/project. The program provides alternatives to incarceration to people who are arrested and jailed as a result of behaviors caused by mental illness. Jail diversion programs can help people who have a serious mental illness, are in jail on a minor charge, are willing to agree to receive treatment for their mental illness, or would not be a risk to the public if they were released from jail.

Vaya Vice President Donald Reuss shared information on the proposed diversion center, which would house a facility-based crisis center, a behavioral health urgent care center, a walk-in clinic, an open access comprehensive clinic, a pharmacy, and a peer living room. The cost to upfit the prospective site is \$4.6 million, not including HVAC. He noted that this is an architectural estimate and subject to change during the construction and bidding process. He stated that the lease execution is pending under the following conditions: rezoning of the property with the City of Henderson; commitment of funding from NC DHHS; and commitment of funding from Vance, Granville and Franklin Counties to support upfit and ongoing operation of the facility.

After lengthy discussion, motion was made by Commissioner Leo Kelly, Jr. to support Vaya Health and the project during this process. This motion was seconded by Commissioner Sean A. Alston, Sr. and unanimously approved.

Water District Board

Chair Yolanda J. Feimster called the Water District Board to order and the September 2023 monthly operations report was presented to the board for information. Chair Feimster adjourned the Water District Board.

Committee Reports and Recommendations

Public Safety Committee - EMS Land Acquisition. Finance Director Katherine Bigelow stated that the committee (Alston/via phone, Brummitt, and Faines); Taylor attending, met on Monday, October 16, 2023 and reviewed a matrix prepared by staff to determine what the committee/commissioners desire in a piece of property. The committee agreed that they would like the land to be in Williamsboro area, and directed staff to put available lands into the Matrix and continue working on moving towards a purchase. Recommendation: Direct staff to continue seeking property for purchase for a northern Vance County EMS substation.

Motion was made by Commissioner Carolyn Faines, seconded by Commissioner Leo Kelly, Jr., vote unanimous, to direct staff to continue seeking property for purchase for a northern Vance County EMS substation.

Public Safety Committee - Vehicle Use Policy. This matter was tabled until the December 6 regular board meeting in order to be further reviewed by the committee and county manager.

Public Safety Committee - Rural Fire Department's Fund Balance Disposal Request and Fire Tax Rate. The committee was presented with a letter from the Vance County Fire and Rescue Association requesting the available fund balance in the Fire Tax fund to be paid out to all the departments. All rural fire chiefs signed the letter. The request was also to leave the tax rate the same on the newly assessed values following the 2024 tax revaluation. This will offset the rising costs in the rural departments providing services to Vance County. The committee recommended that the fund balance be left in place and not disperse the monies until the fire study and tax revaluation are complete. It was noted that staff sent information to all fire chiefs regarding the state appropriation funding for rural fire departments, if they choose to need funding.

Public Safety Committee - Uniforms. The committee stated that if a department is provided uniforms, employees are expected to wear those uniforms on a regular basis.

Finance Director's Report

Education Lottery Fund Applications. Finance Director Katherine Bigelow stated that a joint application filed by the county commissioners and the board of education must be submitted to the state in order to draw down available North Carolina Education Lottery funds from the Public School Building Capital Fund. The county has budgeted to use lottery funds to pay the debt service for the 2010 QSCB and 2013 QZAB projects. The board of education approved the applications at its October 9, 2023 meeting for \$384,775.96. Recommendation: Approve the

applications to draw down lottery funds to be used for debt service payments on existing school facilities debt.

Motion was made by Commissioner Dan Brummitt, seconded by Commissioner Carolyn Faines, vote unanimous, to approve the applications to draw down lottery funds to be used for debt service payments on existing school facilities debt.

FVW Head Start Lease Agreement. Ms. Bigelow noted that after meeting all statutory requirements, we are ready to proceed with approving the lease agreement for the kitchen at the Eaton Johnson Complex to FVW Head Start. Recommendation: Approve the lease amendment for FVW Head Start Program.

Motion was made by Commissioner Carolyn Faines, seconded by Commissioner Sean A. Alston, Sr., vote unanimous, to approve the lease amendment for FVW Head Start Program for use of the kitchen at the Eaton Johnson Complex.

- WHEREAS, pursuant to NCGS § 153A-176 and 160A-272, Vance County may, upon such terms and conditions as it deems wise, with or without consideration, lease any interest in real property; and
- **WHEREAS**, Vance County did previously, lease to Franklin-Vance-Warren Opportunity, Inc. a portion of the building located at 500 N. Beckford Drive, Henderson, North Carolina; and
- WHEREAS, Franklin-Vance-Warren Opportunity, Inc. has requested to lease additional space that is now available at the same location; to wit; 3,632 square feet commercial kitchen area and non-exclusive rights to the use of the loading dock located within the same Eaton Johnson Complex; and
- **WHEREAS**, Vance County had previously determined this section of the complex would not be needed during the term of the lease, and does continue to affirm such determination.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners for the County of Vance as follows:

- The real property known as the 3,632 square feet commercial kitchen and non-exclusive use of the loading dock located within the Eaton Johnson Complex located at 500 N. Beckford Drive, Henderson, North Carolina is not needed by the County for the term of the proposed lease attached hereto and incorporated by reference.
- 2. The first lease amendment (attached hereto and incorporated by reference) to include this additional real estate with an initial term through June 30, 2027, with one additional lease term extensions for five years (July 1, 2027-June 30, 2032), and a rental rate of \$10 per square foot per year is hereby authorized and approved.
- 3. A notice of the proposed lease as required by NCGS 160A-272 was published on October 3, 2023.

4. The Chair or the Interim Vance County Manager are hereby authorized to execute any and all documents related to affecting the above authorized first lease amendment.

Industrial Park - Road and Sewer Project Bid Opening. Finance Director Katherine Bigelow provided minutes and budget from the bid opening, noted by Grant Administrator Frank Frazier with Kerr-Tar Council of Governments. She noted that the total project budget is \$1,314,880 and the lowest bid was \$1,149,379.60 submitted by Triangle Grading. This leaves a shortfall of \$138,390. She stated that in order to move forward with the EDA grant, the shortfall funding needs to be secured even if it is not utilized. She recommended approval of Budget Amendment #9 to appropriate \$138,390 as county contribution to fulfill funding.

Motion was made by Commissioner Carolyn Faines to approve Budget Amendment #9 as presented. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Purpose: Shortfall of road and sewer project in the industrial park, to secure the EDA and Commerce grant.

Authorization:

Clean-up of Former Vance Manor Site. Ms. Bigelow noted that Chair Feimster had requested staff to get quotes to clean up county owned land at the old Vance Manor site on County Home Road. She stated that staff received quotes and would like to proceed with Woodlief's Lawn care for \$2,900, which is for brush/debris cutting and removal of five acres. To maintain it each year will be much less expensive. She stated that there are funds in contingency to cover this expense and no appropriation is needed. Recommendation: Authorize staff to work with Woodlief's lawn care as presented.

Motion was made by Commissioner Carolyn Faines to authorize staff to work with Woodlief's Lawn Care to clear brush/debris at the old Vance Manor site on County Home Road. This motion was seconded by Commissioner Sean A. Alston, Sr. and unanimously approved.

Resolution - Operation Green Light. Ms. Bigelow noted that Operation Green Light is an initiative endorsed by the NC Association of County Commissioners (NCACC), the National Association of Counties (NACo), and the National Association of County Veteran Service Officers (NACVSO) that shows support and honor for military veterans. During Operation Green Light, residents and businesses are asked to shine a green light or light their buildings green from November 6 to November 12 as a way of letting veterans know they are seen, appreciated, and supported. The resolution supports this effort, which will include lighting the exterior lights at the Henry Dennis Building green. Commissioner Dan Brummitt suggested that green lights be installed at other county buildings as well. It was noted that all other buildings use LED lights, but staff would double check to make sure.

Motion was made by Commissioner Carolyn Faines, seconded by Commissioner Sean A. Alston, Sr., vote unanimous, to approve the following resolution supporting Operation Green Light for veterans.

Eaton Johnson Chiller Pump Replacement. Ms. Bigelow reported that there are eight pumps and an air handler that need to be replaced at the Eaton Johnson Complex main building. Only \$195,000 was budgeted for this project including engineering, which at the time was sufficient. She recommended approval of Budget Amendment #7 to appropriate necessary funds, and to award the bid to Gupton Services.

Commissioner Leo Kelly, Jr. echoed these remarks and stated that the resolution would tie the hands of the county manager.

Hester, Jr., Leo Kelly, Jr. and Archie B. Taylor, Jr.
