COUNTY OF VANCE

The Vance County Board of Commissioners met in regular session on Monday, March 11, 2013 at 6:00 p.m. in the Commissioners' Conference Room, Vance County Administration Building, 122 Young Street, Henderson, NC. Those Commissioners present were as follows: Chairman Thomas S. Hester, Jr., Commissioners Deborah F. Brown, Dan Brummitt, Terry E. Garrison, Archie B. Taylor, Jr., Gordon Wilder, and Eddie L. Wright.

Absent: None.

Also present were County Manager Jerry L. Ayscue, Finance Director David C. Beck, County Attorney Jonathan S. Care, and Clerk to the Board Kelly H. Grissom.

Commissioner Eddie L. Wright gave the invocation.

Mr. Stuart Litvin, Economic Development Director, extended an invitation to the Vance County Board of Commissioners to join the EDC Board for a special March meeting. The guest speaker for this meeting will be Mr. Billy Ray Hall, President of the NC Rural Center. The meeting will be at 1:30 p.m. on Wednesday, March 20th in the Vance County Board of Commissioners meeting room.

County Manager Jerry L. Ayscue introduced Mr. David Beck as the new County Finance Director. Mr. Beck comes to us from Davie County where he served as the Assistant County Finance Director. The Commissioners welcomed Mr. Beck to Vance County and stated that they look forward to working with him.

Mr. Jordan McMillen, Planning Director, was first on the agenda and explained that a public hearing had originally been scheduled for 6:00 p.m. regarding an amendment to the Flood Damage Prevention Ordinance. He stated that the newspaper did not run the public notice on the required date, so it will need to be published again, and the hearing will be held at the April 8th meeting.

Mr. McMillen gave a brief overview of the amendment and stated that this is a federally mandated change for the County to be able to continue to offer flood insurance to those residents affected. Overall, the change was very minor in that the flood plain was only increased by one to one and a half feet in some areas.

This matter will be addressed again during next month's meeting.

The next item on the agenda was an appeal from Maria Parham Medical Center for business personal property. County Attorney Jonathan S. Care explained that Maria Parham's personal property is currently listed in the amount of \$21,326,662.

The appellant states that the value of the business personal property should be \$12,314,106, but no basis has been provided by Maria Parham indicating how they came to this amount or why the amount should be adjusted. When Maria Parham listed their property in 2012, the County provided that listing to our auditor because the amount did not seem to be accurate. After the auditor's assessment, it was determined that the amount was in fact not accurate.

Porcha Brooks, Tax Administrator, stated that Maria Parham has not provided information that was asked for in order for the County to make any adjustments. She recommended that the business personal property value remain as is.

Motion was made by Commissioner Deborah F. Brown to follow the assessor's recommendation that the business personal property value remain at \$21,326,662. The assessor office also recommends that the appellant provides the County with the historical cost of the equipment. This motion was seconded by Commissioner Eddie L. Wright and unanimously approved.

The next item addressed was the Community Hero recognition. Chairman Thomas S. Hester, Jr. recognized the Northern Vance High School Engineering Team and asked them to come forward. Chairman Hester stated that the team was led by Dr. Jeff Arthurs and the members include Justin Care, Ray Cheever, Dylan Grissom, Nick Sharpe, and Amber Stevenson. The team won the Prize for Innovation contest through the NC State University's Institute for Emerging Issues. Governor Pat McCrory presented the team the award during the Emergency Issues Forum on February 12 at the Raleigh Convention Center. They won the award over four other finalists representing high schools from across North Carolina. The additional finalists included two student teams from the NC School of Science and Math in Durham, a student team from Hillside High School in Durham, and a student team from Havelock High School in Havelock. The team's entry in the contest was the Sirocco Innovative Computer Cleaner, a device designed to dislodge and remove dust that can interfere with a computer's critical functioning parts. A local company, Salare, Inc., assisted the students in building a prototype of

their invention. With their Prize for Innovation award, the team received a \$5,000 cash award to use toward the development of their Sirocco creation.

In the competition, the Northern Vance team submitted a contest application, essays about their work and a PowerPoint file that included pictures of their creation. Once the team was chosen as a finalist for the award, they developed and submitted a video to illustrate their innovative idea. The video was placed on You Tube on January 25 for public viewing. The final part of the contest involved online voting for the five finalist teams. Over 12,000 votes were cast, with the Northern Vance team receiving approximately 6,000 of those votes to easily out distance the other teams.

Chairman Hester congratulated the team and presented them with a certificate and check for \$25.00.

Public comments were heard next. Mr. Rudy Abate expressed his concerns with the need of a new animal shelter and offered to sell his kennel to the County to be used as a new shelter.

Michael Bobbitt spoke regarding the Community Development Block Grant Program, the contract with Envirolink, Inc., and computers for commissioners.

At this time, Chairman Thomas S. Hester, Jr. called the Water District Board to order.

County Manager Jerry L. Ayscue explained that proposals had been requested some time back for operations and maintenance of the county water system. The Board selected Envirolink, Inc. as the company of choice and instructed the staff to come back to the Board with a proposed contract with said company. Mr. Ayscue presented a contract which has been reviewed by the Planning and Environmental Committee.

County Attorney Jonathan S. Care stated that the contract is set to last in five year increments and is scheduled to begin as soon as Phase 1 is turned over to the County and is approved. The contract includes a set cost for the billing (operations) and emergency repairs. Those set charges may be changed once a year as costs change. Policies and procedures will also need to be developed once this contract is executed.

Commissioner Dan Brummitt stated that he had asked for information during the Planning and Environmental Committee meeting on February 28 regarding water costs to customers. He expressed his displeasure with the fact that he has not yet received this information.

Attorney Care explained that a rate model is just one variable to be developed by Envirolink with active input from the Board and staff; however, this cannot be done until after policies have been developed and a contract is in place.

Mr. Mike Myers, Envirolink, Inc., was present and stated that rates have been looked at, but without the development of policies for these rates, there is such a wide range that any rate given today may change once those policies are in place. One example is customer accounts that have not yet been defined. This will have a tremendous impact on the rates.

It was noted that Envirolink will draft these policies and present to the Planning and Environmental Committee for review.

Commissioner Terry E. Garrison stated that Envirolink should be able to provide estimates on water rates. Commissioners Brummitt and Wilder echoed this and stated that they would like this information before the contract is approved.

Commissioner Archie B. Taylor, Jr. stated that this contract is for the management of the water system and has nothing to do with monthly water rates.

Motion was made by Commissioner Eddie L. Wright to approve the contract with Envirolink, Inc. as presented. This motion was seconded by Commissioner Archie B. Taylor, Jr. and vote was ayes - four (4); noes - three (3), with the dissenting votes being cast by Commissioners Brummitt, Garrison and Wilder.

Rob Bernard, Hobbs Upchurch and Associates, appeared before the Board and stated that he would have some cost estimates to Commissioner Brummitt by next Monday. He also sought approval of three change orders for the water project. The first change order was for Contract 1 for seeding, pipe modifications and boring in the amount of \$118,887.52. He explained that the change for seeding is due to the fact that the State changed its requirements after we had already begun the project. If those requirements had been in place, they would have been budgeted. We are, however, still within the overall budget.

Motion was made by Commissioner Deborah F. Brown, seconded by Commissioner Archie B. Taylor, Jr., vote unanimous, to approve Contract 1, Change Order #2 for seeding, pipe modifications, and boring in the amount of \$118,887.52.

Motion was made by Commissioner Deborah F. Brown, seconded by Commissioner Archie B. Taylor, Jr., vote unanimous, to approve Contract 2, Change Order #1 for seeding and piping in the amount of 152,048.00.

The next change order presented was for a decrease in the amount of \$11,631.90 for pipe modifications. Motion was made by Commissioner Eddie L. Wright, seconded by Commissioner Deborah F. Brown, vote unanimous, to approve Contract 4, Change Order#2 in the amount of \$11,631.90 (decrease).

At this time, Chairman Thomas S. Hester, Jr. adjourned the Water District Board.

Committee Reports and Recommendations

Human Resources Committee - Position Vacancies. Human Resources Director Argretta Johen requested the Board to allow filling the following position vacancies which have been endorsed by the Human Resources Committee:

Motion was made by Commissioner Eddie L. Wright, seconded by Commissioner Dan Brummitt, vote unanimous, to approve the position requests as presented.

Human Resources Committee - NACo Dental Discount Program. Ms. Johen stated that NACo has launched a dental discount program to be made available to all citizens. She distributed information to the Board for review. This item will go before the Human Resources Committee for review and a recommendation will be brought back to the full Board.

Planning and Environmental Committee - Water Matters. This item was addressed earlier under the Water District Board.

County Manager's Report

REO Properties. Attorney Care noted that the Board of Commissioners approved the public sale process for a lot on the north side of I-85 in Henderson, NC. The property was advertised for upset bids and none were received. The Board is now free to accept or reject the original offer. This should be done by resolution.

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Dan Brummitt, vote unanimous, to approve the following resolution accepting the bid for a lot on the north side of I-85 in Henderson, NC.

Attorney Care asked the Commissioners if they would like any other information on REO Properties from this point forward. Commissioner Archie B. Taylor, Jr. stated that he would like to have tax values on adjoining properties. The Board also asked Attorney Care to place these properties on the County's website.

County Manager's Report

Update/Action on CDBG Housing Project. Mr. Ayscue provided an update on a CDBG Housing Project on Stagecoach Road. He explained that this housing project involves demolition and new construction. Mel's Electric and Plumbing was awarded the low bid and demolition occurred satisfactorily. New construction began and slowly moved forward until the contractor stopped working altogether. The County had to have another contractor temporarily cover the roof due to the contractor not putting shingles on. No other work has occurred on the project. The deadline for completion of this project passed in late February. The original contractor, Mel's Plumbing, has been duly notified of termination of the contract. The County Attorney has been involved in that action.

The second low bidder on the project is Clement Construction who has agreed to finish the construction and make the necessary improvements and damage adjustments to the prior construction work in order to properly warranty the project. Clement Construction's price is \$58,100 to complete the entire project, which adds \$19,350 to the total cost. This amount is allowable under the CDBG Program and will not be the responsibility of the County or the homeowner. Mr. Ayscue stated that according to the State, this is not an uncommon problem; however, we have been fortunate and not previously encountered this type of situation.

County Attorney Jonathan S. Care recommended that the Board officially terminate the contract with Mel's Plumbing and award the bid to Clement Construction in the amount of \$58,100.

Motion was made by Commissioner Deborah F. Brown to declare that Mel's Plumbing is in default of the original contract and award the bid to the second lowest bidder, Clement Construction, in the amount of \$58,100. This motion was seconded by Commissioner Dan Brummitt and unanimously approved.

Resolution - Spring Litter Sweep. Mr. Ayscue stated that each spring and fall, the NC Department of Transportation conducts a statewide sweep of roadsides as a means of cleaning and beautifying the State. The 2013 Spring Litter Sweep is set for April 13-27. He recommended that the Board adopt a resolution in support of the 2013 Spring Litter Sweep in Vance County.

Motion was made by Commissioner Gordon Wilder, seconded by Commissioner Eddie L. Wright, vote unanimous, to adopt the following resolution in support of the 2013 Spring Litter Sweep in Vance County:

Update on Computers for Commissioners. Mr. Ayscue reported that all computers that were ordered for Commissioners have been received. If all goes well, the Board should have their devices at its next meeting in April.

Commissioner Deborah F. Brown suggested that the Board do a “dry run” with the new computers before the next meeting. Commissioner Dan Brummitt suggested that during the transition, the Board be given a hard copy of the agenda as well as an electronic copy.

NC Rural Center Internship. Mr. Ayscue reported that through funding by the NC State Employees Credit Union, the North Carolina Rural Economic Development Center is sponsoring a summer internship program for students in North Carolina community colleges and universities who may want to work in county government. The Rural Center will pay the student and the County if the County and student are selected. A letter of interest has been submitted to the Rural Center by the County Manager.

Animal Shelter Plans. Mr. Ayscue stated that as the proposed budget for the upcoming fiscal year is developed, it is appropriate to determine if funds for planning, design, etc. of an animal shelter should be included. While factoring in discussion points made at the Planning Retreat in January, some Commissioners have asked if funds should be reserved or otherwise

budgeted for next fiscal year. Guidance from the Board would be helpful as the proposed budget is developed. Further, it is necessary to obtain a special use permit in order to construct an animal shelter on the piece of donated property. Development of plans by an architect will provide the cost estimate to allow the County to make adequate financial plans.

Motion was made by Commissioner Dan Brummitt to allow staff to apply for a special use permit from the City of Henderson. This motion was seconded by Commissioner Gordon Wilder and unanimously approved.

Motion was made by Commissioner Archie B. Taylor, Jr. that if there are any associated fees with obtaining the special use permit, the County Manager is authorized to use up to \$3,200 to do so. This motion was seconded by Commissioner Eddie L. Wright and unanimously approved.

Commissioner Deborah F. Brown stated that any other requests for funding will be reviewed during the budget process. The Board will have other requests that will need to be addressed also. She stated that while a new animal shelter is needed, she cautioned the Board to be mindful of all spending before making a decision on the shelter. This may not be the proper time for a new shelter.

At this time, Commissioner Terry E. Garrison suggested that a meeting be held to address the recent crime spree in the community. The Board of Commissioners, Henderson City Council, law enforcement officials, judges, district attorney, etc. should be involved in this meeting. He stated that the public needs some type of response from its elected officials. Commissioners Brown and Wright agreed with this.

Motion was made by Commissioner Terry E. Garrison to ask the County Manager to coordinate a planning session to address the recent crime spree in the community. This motion was seconded by Commissioner Deborah F. Brown and unanimously approved.

Pending Business

County Water Project. Phase 1A. Mr. Ayscue reported that as of the first of March, a total of 849 customers have been enrolled in Phase 1A, and there are 14 additional dry taps. Additional roads will be presented to Commissioners for inclusion in Phase 1A through the traditional change order process. Engineers and staff continue to work together to identify and prepare additional roads for extension of lines and will work through the Planning & Environmental Committee in identifying the added areas. Construction of the elevated storage

tank is almost completed, pending one additional change order. Painting of the tank is scheduled to be finalized by the end of April, weather permitting. Three full-time work crews continue working on line installations. Just over 90% of the construction of Contract 1 has been completed and about 60% of Contract 2 is complete. Some water taps and meter boxes have been put in along a portion of the installed lines areas. County staff continues to deliver letters and pin flags to residents who have purchased taps for installation of the meter boxes. Monthly construction meetings are being held with work crews, engineers, DOT officials, etc. to coordinate on various issues with construction, safety, billing, traffic control, etc. Policies have to be developed for rate and fee schedules, cross connections, water conservation, and tank leasing. Staff will use the Planning & Environmental Committee to review policies prior to submission to the Water Board for approval. *Phase 1B*. USDA Rural Development and Kittrell Water Association continue to work together to seek funding for Phase 1B, consistent with action taken by the Commissioners in December 2009. *Phases 2A & 2B*. The County has submitted a request for an extension of time for ARRA grant and loan funding for Phases 2A and 2B, but no official notification of waiver approval has been received. Regional and state USDA RD staffs encourage the County to continue to proceed as expeditiously as possible and we are operating on that premise. A preliminary sign-up analysis has been completed for these two phases which will enable the County to know which project areas to bid initially. All State permits have been obtained. Erosion control permits and permits from the Army Corps of Engineers have been acquired. Kerr Lake Operations staff members are processing new easements for crossing of Kerr Lake. Submission of application information to USDA Rural Development is continuously being done for both phases. Sites for the water tank and one meter vault in the area covered by Phase 2A and 2B have been approved by the Schools System. Negotiations have taken place with two additional property owners for two meter vault sites and options to purchase are currently being processed. Engineers are pursuing a lake crossing permit and a Kerr Lake Reservoir utility crossing easement through the U.S. Army Corps of Engineers. There are some low pressures concerns in the Poplar Creek Road area that are being studied and addressed. The attorney's opinions have been completed and submitted to USDA RD. Now that all required permits have been obtained, it is anticipated that the Water District can go out to bid later this month. The approved O&M services contract will cover Phases 2A and 2B in addition to 1A. Additional sign-ups remain essential in Phases 2A and 2B due to the current lack of

substantial customer concentration. Current sign-up totals are 367 for Phase 2A and 374 for Phase 2B.

VFD Contracts and Audits. Mr. Ayscue noted that contact was made with Drewry VFD and he was informed that they will receive their audit report by next Monday. All other reports that are due have been received.

Consent Agenda

Commissioner Dan Brummitt asked that a newspaper article in the Social Services monthly report be pulled from the consent agenda. It was listed as being corrected but is still incorrect.

Motion was made by Commissioner Deborah F. Brown, seconded by Commissioner Dan Brummitt, vote unanimous, that the following consent agenda items be approved as presented: January 2013 Tax Refunds and Releases, February 2013 Monthly Reports received and filed, and the minutes of the February 4, 2013 regular meeting.
